### PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient to make provision for the licensing of Insurance Agents in the Bechuanaland Protectorate (hereinafter referred to as "the Territory");

Now therefor under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows :-

1. Any person who within the Territory sells or offers for sale any policy of insurance or canvasses for the sale or issue of any such policy whether such policy be for fire, accident, life or any other kind of insurance, shall before commencing or continuing such business take out a licence for the then current year ending the thirty-first day of December, on which licence the sum of £5 shall be payable, and thereafter the sum of £5 annually during the whole or any part of any year during which he shall carry on business.

2. This Proclamation shall have force and take effect from the first day of January, 1935.
