It is hereby notified for general information that, under and by virtue of the powers in him vested by section *three* (4) and section *four* of Act No. 10 of 1911 of the Union of South Africa, as of force in the Bechuanaland Protectorate in terms of Proclamations No. 28 of 1916 and No. 23 of 1928, His Excellency the High Commissioner has been pleased to approve, with effect from the first day of November, 1934, of the subjoined regulations made by the Postmaster-General, with the concurrence of the Resident Commissioner, amending the Telephone Regulations of the Bechuanaland Protectorate, published in Schedule B to the aforesaid Proclamation No. 23 of 1928.
