PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient to amend in certain respects the Proclamation of the 10th June, 1891 (hereinafter referred to as the principal law) in relation to Trading Licences in the Bechuanaland Protectorate;

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

1. Section twenty-three of the principal law is amended by adding the following proviso:

"Provided, however, that no Mission, School or other educational institution shall be required to take out a licence in respect of the sale of goods produced or manufactured by the scholars or inmates of any such Mission, School or institution in the ordinary course of their education".

2. This Proclamation may be cited as the Bechuanaland Protectorate General Dealers' Licences Amendment Proclamation, 1934, and shall have force and take effect from the date of its publication in the Gazette.

PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to preserve natural and historical monuments, relics and antiques in the Bechuanaland Protectorate (hereinafter referred to as "the Territory") and to control the export from the Territory of antique objects and

articles of historical value;
Now therefore under and by virtue of the powers in me vested, I do hereby declare, proclaim and make known as

follows:

- 1. The Resident Commissioner may by notice in the Gazette proclaim to be-
 - (a) a monument, any area of land having a distinctive or beautiful scenery or geological formation, any area of land containing a rare or distinctive or beautiful flora or fauna, any area of land containing objects of archaeological interest, any waterfall, cave, grotto, avenue of trees, old tree or old building and any other

- object (whether natural or constructed by man) of aesthetic, historical, archaeological or scientific value or interest;
- a relic, any fossil of any kind, any drawing or painting on stone or petroglyph known or commonly believed to have been executed by Bushman or other aborigines of South Africa, or by any people who inhabited or visited South Africa before the advent of the Europeans, and any implement or ornament known or commonly believed to have been used by them, and any anthropological or archaeological contents of the graves, caves, rock shelters, middens, shell mounds or other sites used by them;
- them;
 (c) an antique, any movable object (not being a monument or relic) of aesthetic, historical, archaeological or scientific value, or interest, the whole or more valuable portion whereof has for more than one hundred years been in any part of South Africa, or which was made therein more than one hundred years before the publication of the said notice.
- 2. (1) Whenever the owner of any object proclaimed under the provisions of section *one* alienates, pledges or lets it he shall forthwith inform the Resident Commissioner of the name and address of the alienee, pledgee, or lessee.
- (2) No person shall, without the written consent of the Resident Commissioner, destroy or damage any monument or relic or make any alteration thereto or remove it from its original site or export it from the Territory.
- (3) Any person desiring to remove any monument or relic from its original site or to export it from the Territory shall, when applying to the Resident Commissioner for his consent, supply the Resident Commissioner with a drawing or photograph of the monument or relic in question and shall state the exact locality in which it is situated and the place to which and purposes for which it is desired to remove or to export it.
- (4) No person having control of any antique shall without the written consent of the Resident Commissioner destroy or damage it or export it from the Territory.
- (5) Any person desiring to export any antique from the Territory shall, when applying to the Resident Commissioner for his consent, supply him with a photograph and description thereof and shall state the place to which and purpose for which it is desired to export the antique.
 - 3. Any person who knowingly-
 - (a) fails to comply with or contravenes any provision of section two, or
 - (b) in any application to the Resident Commissioner for his consent makes any statement which is false in any material respect or supplies therewith any drawing or photograph which is false in any material respect,

shall be guilty of an offence and liable on conviction to a fine not exceeding one hundred pounds or in default of payment to imprisonment not exceeding six months, and in the case of the unauthorized export of an antique the said fine may be increased to a sum not exceeding seventy-five per cent. of the market value of such antique.

4. In this Proclamation-

"antique" means an object proclaimed by the Resident Commissioner as such under the provisions of section one;

" monument " means an area or object proclaimed by the Resident Commissioner as such under the provisions of

section one; elic " means an object proclaimed by the Resident Commissioner as such under the provisions of section one.

5. This Proclamation may be cited as the Natural and Historical Monuments, Relics and Antiques (Bechuanaland Protectorate) Proclamation, 1934, and shall have force and take effect from the date of its publication in the Gazette.

PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is deemed desirable to prohibit the exportation of warlike stores from Swaziland (hereinafter referred to as "the territory");

- 1. The exportation of warlike stores from any place within the territory to Bolivia or to Paraguay is prohibited until further notice.
- 2. It shall be lawful for any officer appointed by the Resident Commissioner or for any European member of a police force lawfully established in the territory to detain and examine any warlike stores or any packages or vehicles suspected of containing warlike stores for the purpose of enforcing the prohibition contained in the preceding section.
- 3.
