PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to amend in certain respects the Swaziland Public Service Motor Vehicle Proclamation, 1934 (No. 18 of 1934), hereinafter referred to as the principal law;

therefore under and by virtue of the authorities and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909, I do hereby declare, proclaim and make known as follows:—

- 1. The principal law shall be and is hereby amended as follows:
 - By the deletion of the word "ordinarily" from the definition of a "Public Service Motor Vehicle" in (a) By section one;
 - (b) by the deletion of the words "or equipment" in subsection (2) of section three;
 (c) by the repeal of section six.
- 2. This Proclamation may be cited for all purposes as the "Public Service Motor Vehicle 1934 Amendment Proclamation, 1934", and shall have force and take effect from the date of its publication in the Gazette.
