PROCLAMATION

By His Excellency the High Commissioner.

Whereas it is expedient to make provision for the impounding of animals found trespassing on Aerodromes in the Bechuanaland Protectorate (hereinafter referred to as "the Territory") and for that purpose to amend the Bechuanaland Protectorate Pounds and Trespasses Proclamation 1925 (No. 12 of 1925) (hereinafter referred to as "the said Proclamation");

Now therefore under and by virtue of the powers in me vested, I do hereby declare, proclaim and make known as follows:—

1. Section *two* of the said Proclamation shall be and is hereby amended by the addition of a further definition reading as follows:—

" 'Aerodrome' shall mean an area of land demarcated by visible beacons and used in connection with aviation in the Territory, provided such area has been fully described by the Resident Commissioner in a Notice in the *Gazette*.

2. Section *thirty-six* of the said Proclamation shall be and is hereby repealed and the following section inserted in lieu thereof:

" 36. Every Magistrate, Police Officer, Justice of the Peace and any other person authorized in writing by any of the said persons may impound any animals found

- (a) upon any outspan place of vacant Crown land in any district, which are not in the possession of travellers who have outspanned for not more than twenty-four hours, or for any period during which they may be detained by stress of weather or other sufficient cause upon the outspan place; or
- (b) upon any aerodrome."

3. Section *thirty-seven* of the said Proclamation shall be and is hereby amended by the insertion of the words "or aerodrome" after the word "land".

4. This Proclamation may be cited for all purposes as the Bechuanaland Protectorate Pounds and Trespasses (Amendment) Proclamation 1935, and shall have force and take effect from the date of its publication in the *Gazette*.
