PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient to proclaim certain portions of land in Swaziland to be Crown lands;

Now the fore under and by virtue of the powers, authori-Now the fore under and by virtue of the powers, authori-ties and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council, 1903, as amended by the Swaziland Order-in-Council, 1906, and the Swaziland Order-in-Council, 1909, and by virtue of the further authority conferred upon me under the Swaziland Crown Lands and Minerals Order-in-Council, 1908, as amended by the Swaziland Crown Lands and Minerals Amendment Order-in-Council, 1910, I do hereby declare, proclaim and make known as follows: in-Council, 1910, 1 known as follows:-

The areas of land in Swaziland described in the Schedule to this Proclamation shall, from the date of the publication of this Proclamation in the *Gazette* be Crown lands and shall be registered and known as numbered in the said Schedule, provided always that the proclamation of the said areas as Crown land shall not affect any concession lease servitude or other right subsisting in respect of the said areas which is registered at the date of such publication and is not vested in the Crown in the Crown.

It is hereby notified for general information that, under and by virtue of the powers in him vested by section *fifteen* of the Customs Tariff and Excise Duties Amendment Pro-clamation No. 19 of 1925, as amended. His Excellency the High Commissioner has been pleased to declare that from and

after the twenty-ninth day of May 1935 there shall be charged, levied, collected and paid on bacon and/or ham produced or manufactured in Denmark, Holland, Lithuania, Latvia, Poland and/or Sweden on importation into Basuto-land a bounty dumping duty equal to the amount of the bounty or subsidy granted to the manufacturers in Denmark, Holland, Lithuania, Latvia, Poland and/or Sweden in respect of such bacon and/or ham;

of such bacon and/or ham; Provided that such duty shall not exceed one-half of the value of such bacon and/or ham for duty purposes as defined in section *fourteen* of the Customs Tariff and Excise Duties Amendment Proclamation, 1925, as amended, or in the case of such goods imported on consignment account or for which nominal prices are charged or for which no charge is made, one-half of the value of the goods for duty purposes as defined in terms of section *fourteen* and sub-section (5) of section *fifteen* of the aforesaid Proclamation, as amended; and provided further that such bounty dumping duty shall not be imposed on such bacon and/or ham shipped to Basutoland prior to the above-mentioned date.
