PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient further to amend the Basutoland Death Duties Proclamation, 1935 (No. 20 of 1935);

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:-

- 1. Paragraph (g) of sub-section (2) of section three of Proclamation No. 20 of 1935, as amended by Proclamation No. 12 of 1936, shall be and is hereby repealed, and the following paragraph substituted therefor:—
 - "(g) any stocks or shares in any company whether those stocks or shares are transferable by delivery or by registration and wheresoever such registration may require to be effected; provided that the deceased person whose estate is chargeable with duty was ordinarily resident in Basutoland."
- 2. This Proclamation may be cited for all purposes as the Basutoland Death Duties (Further Amendment) Proclamation, 1936, and shall have force and take effect as from the date of its publication in the Gazette.

BASUTOLAND.

CUSTOMS: DUMPING DUTY ON METAL MANUFACTURES.

It is hereby notified for general information that, under and by virtue of the powers in him vested by section fifteer of the Customs Tariff and Excise Duties Amendment Proclamation, 1925, as amended, His Excellency the High Commissioner has been pleased to declare that from and after the fifth day of June, 1936, there shall be charged, levied collected and paid on all black steel plates and/or sheets except those exceeding 4 feet by 12 feet by \$\frac{3}{16}\$, of an inch is any one dimension on importation into Basutoland from the United States of America an "ordinary dumping duty equal to the difference between the "exporprice" as defined in section nineteen of the Customs Tarif and Excise Duties Amendment Proclamation, 1925, a amended, and the "domestic value" thereof as defined in that section, plus the extra cost of packing and packages for export, carriage to port of shipment and all other expense incidental to placing such goods on board ship ready for export to Basutoland, provided—

(a) that such difference is greater than five per centum of

(a) that such difference is greater than five per centum o the export price, and

(b) that such duty shall not exceed one-half of the value for duty purposes of the black steel plates and/o sheets referred to above, as defined in section fourteer of the Customs Tariff and Excise Duties Amendmen Proclamation, 1925, as amended, and
(c) that such dumping duty shall not be imposed in respect of such black steel plates and/or sheets shipped to Basutoland from the United States of America prior to the above-mentioned date.
