DEPARTMENT OF AGRICULTURE AND FORESTRY.

The following Government Notice is published for general information.

In terms of sub-section (1) of section twenty-nine of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, ADRIAN PAULUS JOHANNES FOURIE, Minister of Railways and Harbours, Acting in the stead of the Minister of Agriculture and Forestry, hereby notify that the Tobacco Industry Control Board, referred to in section three of the Tobacco Control Scheme, published under Proclamation No. 51 in the Government Gazette No. 2617 of the 21st March, 1939, has in terms of sub-section (1) of Section 18 of that scheme, and with my approval, imposed the following levy upon tobacco:—

- (1) Class (a) Turkish tobacco: one-tenth penny per pound weight;
- (2) Class (b) Flue-cured tobacco: one-fifth penny per pound weight;
- (3) Class (c) All tobacco not included in Class (a) or Class (b): one-fifth penny per pound weight;

and I do hereby further notify that the said levy shall become operative on the 3rd April, 1939.

Ooreenkomsdig subartikel (1) van artikel nege-en-twintig van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, ADRIAN PAULUS JOHANNES FOURIE, Minister van Spoorweë en Hawens, optredende namens die Minister van Landbou en Bosbou, hierby bekend dat die Raad van Beheer oor die Tabaknywerheid, genoem in artikel drie van die Tabakreëlingskema wat by Proklamasie No. 51 in Staatskroerant No. 2617 van 21 Maart 1939 gepubliseer is, kragtens subartikel (1) van artikel 18 van daardie skema en met my goedkeuring, die volgende heffing op tabak gelê het:—

- (1) Klas (a), Turkse tabak: een-tiende pennie per pond gewig;
- (2) Klas (b), Oondgedroogde tabak: een-vyfde pennie per pond gewig;
- (3) Klas (c), Alle ander tabak wat nie onder Klas (a) of Klas (b) val nie: een-vyfde pennie per pond gewig;

en ek maak hierby verder bekend dat genoemde heffing op 3 April 1939 van krag word.
