AMENDMENT OF REGULATION No. 45, PUBLISHED UNDER GOVERNMENT NOTICE No. 494 OF 1937.

It is hereby notified for general information that His Excellency the Governor-General has been pleased to approve, under the provisions of sub-section (1) of section forty-eight of the Native Trust and Land Act, 1936 (Act No. 18 of 1936), of the following amendments to regulation No. 45, published under Government Notice No. 494 of 1937:—

- (a) The deletion of paragraphs (e) and (f) of sub-section (1), and the insertion in lieu thereof of the following new paragraph:
 - (e) Any member of the family of any such person as is referred to in sub-paragraphs (a), (b), (c) or (d) who is dependent upon him, and any bona fide employee, other than an Asiatic, of any such person.
- (b) The deletion of sub-section (3). The existing sub-section (4) becoming sub-section (3).

IMPORTATION OF TOBACCO FROM SOUTHERN RHODESIA.

His Excellency the Governor-General has been pleased, under the powers vested in him by section two of the Union and Southern Rhodesia Trade Agreement Act, 1935 (Act No. 14 of 1935), to make the following regulation:—

1. For the purposes of regulation No. 5 of the regulations published under Government Notice No. 929 of the 28th June, 1935, the Secretary for Agriculture and Forestry shall determine the quantity of flue-cured Virginia tobacco for

WYSIGING VAN REGULASIE No. 45, GEPUBLISEER ONDER GOEWERMENSKENNISGEWING No. 494 VAN 1937.

Hierby word bekendgemaak dat dit Sy Eksellensie die Goewerneur-generaal behaag het om onder die bepalinge van subartikel (1) van artikel ag-en-veertig van die Naturellesake- en -grond Wet, 1936 (Wet No. 18 van 1936), sy goedkeuring te heg aan die volgende wysiging tot regulasie No. 45, gepubliseer onder Goewermentskennisgewing No. 494 van 1937:—

INVOER VAN TABAK UIT SUID-RHODESIË.

Dit het Sy Eksellensie die Goewerneur-generaal behaag om, kragtens die bevoegdheid hom verleen by artikel twee van die Wet op die Handelsooreenkomste tussen die Unie en Suid-Rhodesië, 1935 (Wet No. 14 van 1935), die volgende regulasie te maak:—

1. Vir die toepassing van regulasie No. 5 van die regulasies gepubliseer by Goewermentskennisgewing No. 929 van 28 Junie 1935, stel die Sekretaris van Landbou en Bosbou die

the importation of which a permit is to be issued to any applicant.

In making any such determination the Secretary for Agriculture and Forestry may take into consideration—

- (a) the total number of manufacturers of tobacco who have applied or are in his opinion likely to apply for such permits in respect of the period of twelve months commencing on the first day of July in any year;
- (b) the total quantity of flue-cured Virginia tobacco which in his opinion the applicant is likely to use in manufacture during the said period;
- (c) the respective quantities of flue-cured and other light leaf Virginia tobacco actually used in manufacture by the applicant during the preceding calendar year; and
- (d) the respective quantities of flue-cured and other light leaf Virginia tobacco held in stock by applicant at the end of the preceding calendar year.

2. The regulation published under Government Notice No. 590 of 1936 is hereby repealed.

IMPORTATION OF TOBACCO FROM SOUTHERN RHODESIA.

It is hereby notified that, in order to enable the Secretary for Agriculture and Forestry to determine, in terms of Government Notice No. 597 of 28th April, 1939, the quantity of flue-cured Virginia tobacco for the importation of which a permit is to be issued to any applicant, every application for permission for the duty-free importation of flue-cured Virginia tobacco from Southern Rhodesia must be accompanied by a declaration showing the respective quantities of leaf-tobacco which the applicant used in manufacture during the period of twelve months ending on the 31st December immediately preceding the date of the application, as indicated in the schedule hereto.

SCHEDULE.

- (1) Quantity (in weight) of light, air-cured Virginia leaf-tobacco of grades AI to HL, as prescribed in Government Notice 264 of 19th February 1937, produced in the Union.
- (2) Quantity (in weight) of flue-cured Virginia leaf-tobacco of grades FC/AA to FC/HL, as prescribed in the above-mentioned Government Notice, produced in the Union.
- (3) Quantity of flue-cured Virginia leaf-tobacco imported duty-free from Southern Rhodesia.
- (4) Quantity of Virginia leaf tobacco imported duty-free from Northern Rhodesia.
- (5) Quantity of other flue-cured Virginia leaf-tobacco imported into the Union.
- (6) Total stocks of all the above-mentioned types of tobacco as at 31st December, 1938.

- (b) die totale hoeveelheid oondgedroogde Virginia-tabak wat die applikant volgens sy oordeel waarskynlik gedurende genoemde tydperk vir vervaardiging sal gebruik;
- (c) die onderskeie hoeveelhede oondgedroogde en ander ligte Virginia-blaartabak werklik deur die applikant gedurende die voorafgaande kalenderjaar vir vervaardiging gebruik; en

INVOER VAN TABAK UIT SUID-RHODESIË.

Kennis geskied hiermee, dat, ten einde die sekretaris van Landbou en Bosbou in staat te stel om, ingevolge Goewermentskennisgewing No. 597 van 28 April 1939, die hoeveelheid oondgedroogde Virginia-tabak te bepaal, vir die invoer waarvan 'n permit uitgereik sal word, iedere aansoek om vergunning vir die belastingvrye invoer van oondgedroogde Virginia-tabak uit Suid-Rhodesië vergesel moet gaan van 'n verklaring waarin aangegee word die onderskeidelike hoeveelhede blaartabak wat die applikant gedurende die tydperk van twaalf maande, geëindig op die 31ste Desember onmiddellik voor die datum van die aansoek, in vervaardiging gebruik het, soos aangedui in die skedule hierby.

- (1) Hoeveelheid (in gewig) ligte luggedroogde Virginiese blaartabak van grade AI tot HL soos voorgeskryf in Goewermentskennisgewing 264 van 19 Februarie 1937, in die Unie geproduseer.
- (2) Hoeveelheid (in gewig) oondgedroogde Virginiese blaartabak van grade FC/AA tot FC/HL soos voorgeskryf in bostaande Goewermentskennisgewing in die Unie geproduseer.
- (3) Hoeveelheid oondgedroogde Virginiese blaartabak tolvry ingevoer uit Suid-Rhodesië.
- (4) Hoeveelheid Virginiese blaartabak tolvry ingevoer uit Noord-Rhodesië.
- (5) Hoeveelheid ander oondgedroogde Virginiese blaartabak ingevoer in die Unie.
- (6) Totale voorrade van al bostaande soorte tabak op 31 Desember 1938.
