HEFFINGS OP SUIWELPRODUKTE.

Ooreenkomsdig subartikel (1) van artikel *nege-en-twintig*
van die Bemarkingswet, 1937 (Wet No. 26 van 1937), maak
ek, WILLIAM RICHARD COLLINS, Minister van Landbou en
Bosbou, hierby bekend dat die Raad van Toesig op die
Suiwelnywerheid, genoem in artikel 3 van die Skema vir
die Reëling van die Bemarking van Suiwelprodukte wat by
Proklamasie No. 112 van 1939 gepubliseer is, kragtens
artikel 26 van daardie skema en met my goedkeuring die
volgende heffings opgelê het:—

Hierby word op alle fabrieksbotter, plaasmelkerybotter,
fabriekskaaas en plaaskaas 'n heffing van een pennie per
pond gele.

En ek maak hierby verder bekend dat genoemde heffings
vanaf datum van publikasie van hierdie kennisgiving van
krag word.

MARKETING ACT, 1937.

LEVY ON DAIRY PRODUCTS.

In terms of sub-section (1) of section *twenty-nine* of the
Marketing Act, 1937 (Act No. 26 of 1937), I, WILLIAM RICHARD
COLLINS, Minister of Agriculture and Forestry, hereby notify
that the Dairy Industry Control Board referred to in section
three of the Dairy Products Marketing Scheme published
under Proclamation No. 112 of 1939, has, in terms of section
twenty-six of that scheme and with my approval imposed the
following levies:—

There is hereby imposed on all creamery butter, farm
dairy butter, factory cheese and farm cheese, a levy of
one penny per pound.

And I do hereby further notify that the said levies shall
become operative as from date of publication of this notice

BETALING VAN HEFFINGS OP SUIWELPRODUKTE.

Sy Eksellensie die Goewerneur-generaal het, kragtens die bevoegdheid hom verleen by artikel *drie-en-veertig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, die volgende regulasies gemaak in verband met die betaling van heffings op suiwelprodukte, vir die doel van artikel 26 van die Suiwelprodukte-bemarkingskema, gepubliseer by Proklamasie No. 112 van 1939:—

HEFFING OP BOTTER EN KAAS.

1. (1) Die heffing wat deur die Raad op fabrieksbutter, fabriekskaae of plaaskaas gelê is, moet deur elke bottervervaardiger, kaasvervaardiger of plaaskaasmaker, al na die geval mag wees, op die totale hoeveelheid fabrieksbutter, fabriekskaae of plaaskaas deur hom verkoop, aan die Raad te Pretoria betaal word nie later as op die end van die maand na dié waarin daardie fabrieksbutter, fabriekskaae of plaaskaas verkoop is nie.

(2) Wanneer die Raad ingevolge artikel 33 of 36 van die skema 'n verbod opgeleë het, kan hy van die bedrae wat ingevolge paragraaf (c) van subartikel (2) van artikel 34 of paragraaf (c) van subartikel (2) van artikel 37 aan 'n bottervervaardiger, kaasvervaardiger of plaaskaasmaker betaalbaar mag word, die heffings aan die Raad verskuldig deur daardie bottervervaardiger, kaasvervaardiger of plaaskaasmaker aftrek.

HEFFING OP „KONDENSEERMELK”.

2. Die heffing deur die Raad gelê op „kondenseermelk” moet voor die end van elke kalendermaand deur elke „kondensmelkvervaardiger” aan die Raad te Pretoria betaal word op die totale hoeveelheid „kondenseermelk” wat gedurende die voorafgaande kalendermaand deur hom ontvang is.

HEFFING OP PLAASMELKERYBOTTER.

3. (1) Die heffing deur die Raad op plaasmelkerybotter moet, gedurende die tydperk vanaf die eerste dag van Augustus tot die een-en-dertigste dag van Oktober 1939, op dieselfde tye en op dieselfde manier betaal word soos in Goewermentskennisgewing No. 1878 van 1930, soos gewysig by Goewermentskennisgewing No. 2177 van 1930, voorgeskryf ten opsigte van die betaling van die heffing op plaasmelkerybotter ingevolge artikel *actien* van die Wet op die Beheer van die Suiwelnywerheid, 1930.

(2) Vanaf die eerste dag van November 1939 mag niemand plaasmelkerybotter verkoop nie, tensy elke pakkie van daardie botter toegedraai is in 'n spesiale omslag wat by die Staatsdrukker, Pretoria, verkry is en waarop die bedrag van die heffing per pond plaasmelkerybotter deur die Raad opgeleë gedruk is.

(3) Gedrukte omslae is vir die doel van subklousule (2) van hierdie regulasie verkrygbaar by die Staatsdrukker, Pretoria, by voorlegging van 'n kwitansie van die Raad vir die bedrag van die heffing betaalbaar op die aantal pondre plaasmelkerybotter wat gelykstaan met die vereiste aantal omslae, en betaling van 'n bedrag wat deur die Staatsdrukker in oorleg met die Raad vasgestel is om die koste van die papier en enige drukwerk wat daarop vereis mag word, te dek; met dien verstande dat aan geen produsent minder as 5,000 gedrukte omslae waarop sy naam en adres voorkom, by een bestelling verskaf sal word nie.

(4) Die bedrag wat aan die Raad betaal is ten opsigte van gedrukte omslae wat nie gebruik is nie of wat op enige manier beskadig is, sal terugbetaal word, mits daardie omslae aan die Raad terugbesorg word.

HEFFING OP VARS MELK EN VARS ROOM.

4. (1) Die heffing deur die Raad op vars melk gelê, moet nie later as op die laaste dag van elke kalendermaand aan die Raad te Pretoria betaal word—

- (a) deur elke varsmelekprodusent-distribueerder op die totale hoeveelheid vars melk deur hom verkoop, en op die totale hoeveelheid vars melk wat hy gebruik het vir die produksie van vars room deur hom verkoop, gedurende die voorafgaande maand; en
- (b) deur elke varsmelekdistibueerder op die totale hoeveelheid vars melk wat hy gedurende die voorafgaande kalendermaand verkoop het.

(2) Die heffing deur die Raad op vars room gelê moet nie later as op die laaste dag van elke kalendermaand aan die Raad te Pretoria deur elke varsmelekdistibueerder betaal word op die totale hoeveelheid vars room wat hy gedurende die voorafgaande kalendermaand verkoop het.

5. Behalwe waar dit uit die samelhang anders blyk, het elke uitdrukking waaraan in die Bemarkingswet, 1937, soos gewysig, of in die Skema vir die Reëling van die Bemarking van Suiwelprodukte, gepubliseer by Proklamasie No. 112 van 1939, 'n betekenis gegee is, dieselfde betekenis waar dit in hierdie regulasies gespesifieer word.

PAYMENT ON LEVIES ON DAIRY PRODUCTS.

His Excellency the Governor-General has, under the powers vested in him by section *forty-three* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, made the following regulations relating to the payment of levies on dairy products, for the purpose of Section 26 of the Dairy Products Marketing Scheme published under Proclamation No. 112 of 1939:—

LEVY ON BUTTER AND CHEESE.

1. (1) The levy imposed by the Board on creamery butter, factory cheese or farm cheese, shall be paid to the Board at Pretoria by every butter manufacturer, cheese manufacturer or farm cheese maker, as the case may be, on the total quantity of creamery butter, factory cheese or farm cheese sold by him, not later than the end of the month following that during which such creamery butter, factory cheese or farm cheese was so sold.

(2) Whenever the Board has imposed any prohibition under Section 33 or 36 of the Scheme, it may deduct from any amounts which may, in terms of paragraph (c) of sub-section (2) of Section 34 or paragraph (c) of sub-section (2) of Section 37 thereof become payable to any butter manufacturer, cheese manufacturer or farm cheese maker, any levies due to it from that butter manufacturer, cheese manufacturer or farm cheese maker.

LEVY ON CONDENSING MILK.

2. The levy imposed by the Board on condensing milk shall be paid to the Board at Pretoria by every condensed milk manufacturer before the end of every calendar month on the total quantity of condensing milk received by him during the preceding calendar month.

LEVY ON FARM DAIRY BUTTER.

3. (1) The levy imposed by the Board on farm dairy butter shall during the period from the first day of August to the thirty-first day of October, 1939, be paid at the same times and in the same manner as is prescribed by Government Notice No. 1878 of 1930, as amended by Government Notice No. 2177 of 1930, in respect of the payment of levy on farm dairy butter under section *eighteen* of the Dairy Industry Control Act, 1930.

(2) As from the first day of November, 1939, no person shall sell any farm dairy butter unless each package of such butter is enclosed in a special wrapper obtained from the Government Printer, Pretoria, and imprinted with the amount of the levy imposed by the Board per pound of farm dairy butter.

(3) For the purpose of sub-clause (2) of this regulation, imprinted wrappers may be obtained from the Government Printer, Pretoria, on production of a receipt from the Board for the amount of the levy payable on a number of pounds of farm dairy butter equal to the number of wrappers required, and payment of an amount determined by the Government Printer in consultation with the Board to cover the cost of the paper and any printing required thereon; provided that imprinted wrappers bearing the name and address of any producer will not be supplied in quantities less than 5,000 at a time.

(4) Any amount paid to the Board in respect of imprinted wrappers which have not been used or have been spoilt in any way, will be refunded on return of such wrappers to the Board.

LEVY ON FRESH MILK AND FRESH CREAM.

4. (1) Any levy imposed by the Board on fresh milk shall not later than the last day of every calendar month be paid to the Board at Pretoria—

- (a) by every fresh milk producer-distributor on the total quantity of fresh milk sold by him, and on the total quantity of fresh milk used by him for the production of fresh cream sold by him, during the preceding calendar month; and

- (b) by every fresh milk distributor on the total quantity of fresh milk sold by him during the preceding calendar month.

(2) The levy imposed by the Board on fresh cream shall not later than the last day of every calendar month be paid to the Board at Pretoria by every fresh milk distributor on the total quantity of fresh cream sold by him during the preceding calendar month.

5. Except in so far as the context otherwise requires, any expression to which in the Marketing Act, 1937, as amended, or in the Dairy Products Marketing Scheme published under Proclamation No. 112 of 1939, a meaning has been assigned, bears, when used in these regulations, the same meaning.

VERPAKKING EN MERK VAN PLAASMELKERY-BOTTER EN PLAASBOTTER.

Sy Eksellensie die Goewerneur-generaal het, kragtens die bevoegdheid hom verleen by artikel *drie-en-veertig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), die volgende regulasies gemaak in verband met die verpakking en merk van plaasmelkerybutter en plaasbotter:—

1. Niemand mag plaasmelkerybutter of plaasbotter verkoop nie, tensy dit toegedraai is in 'n omslag wat een pond netto van sodanige botter bevat, en waarop aan die buitekant die naam en adres van die produsent van sodanige botter staan, benewens—

- (a) die woorde „plaasmelkerybutter” en „farm dairy butter” in die geval van plaasmelkerybutter; of
- (b) die woorde „plaasbotter” en „farm butter”, in die geval van plaasbotter,

in duidelik leesbare gedrukte hoofletters, minstens 'n kwartduim vierkant.

2. Behalwe waar dit uit die samehang anders blyk, het elke uitdrukking waaraan in die Bemarkingswet, 1937, soos gewysig, of in die Skema vir die Reëeling van die Bemarking van Suiwelprodukte, gepubliseer by Proklamasie No. 112 van 1939, 'n betekenis gegee is, dieselfde betekenis waar dit in hierdie regusasies gebesig word.

3. Iemand wat die bepalinge van hierdie regulasies oortree of verswy om daaraan te voldoen, is aan 'n misdryf skuldig en by veroordeling strafbaar met 'n boete van hoogstens honderd pond.

Sy Eksellensie die Goewerneur-generaal het, kragtens die bevoegdheid hom verleen by artikel *drie-en-veertig*, gelees met paragraaf (a) van subartikel (1) van artikel *negentien* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, die volgende regulasies gemaak in verband met die registrasie van sekere produsente van suiwelprodukte:—

1. Die aansoek van 'n produsent om registrasie ingevolge artikel 29 van die Skema vir die Reëeling van die Bemarking van Suiwelprodukte, gepubliseer by Proklamasie No. 112 van 1939, moet aan die Sekretaris van die Raad van Toesig op die Suiwelnywerheid, Posbus 1284, Pretoria, gerig word.

2. Sodanige aansoek om hernuwing van registrasie moet op of voor die een-en-dertigste dag van Augustus van die jaar ten opsigte waarvan die hernuwing verlang word, by die Sekretaris van die Raad ingedien word.

3. 'n Aansoek ingevolge regulasie 1 of 2 moet—

PACKING AND MARKING OF FARM DAIRY BUTTER AND FARM BUTTER.

His Excellency the Governor-General has, under the powers vested in him by section *forty-three* of the Marketing Act, 1937 (Act No. 26 of 1937), made the following regulations relating to the packing and marking of farm dairy butter and farm butter:—

1. No person shall sell any farm dairy butter or farm butter unless it is enclosed in a wrapper containing one pound nett of such butter and bearing on the outside thereof the name and address of the producer of such butter and—

- (a) in the case of farm dairy butter, the words "farm dairy butter" and "plaasmelkerybutter"; or
- (b) in the case of farm butter, the words "farm butter" and "plaasbotter",

in plainly visible printed capital letters not less than one quarter of an inch square.

2. Except in so far as the context otherwise requires, any expression to which in the Marketing Act, 1937, or in the Dairy Products Marketing Scheme, published under Proclamation No. 112 of 1939, a meaning has been assigned, bears, wherever it is used in the foregoing regulation, the same meaning.

3. Any person who contravenes or fails to comply with the provisions of these regulations shall be guilty of an offence and liable on conviction to a fine not exceeding one hundred pounds.

DAIRY PRODUCTS MARKETING SCHEME.—REGISTRATION OF PRODUCERS.

His Excellency the Governor-General has, under the powers vested in him by section *forty-three*, read with paragraph (a) of sub-section (1) of section *nineteen* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, made the following regulations relating to the registration of certain producers of dairy products:—

1. An application by any producer for registration under section 29 of the Dairy Products Marketing Scheme, published under Proclamation No. 112 of 1939, shall be addressed to the Secretary of the Dairy Industry Control Board, Box 1284, Pretoria.

2. Any such application for the renewal of any registration shall be lodged with the Secretary of the Board on or before the thirty-first day of August in the year in respect of which the renewal is desired.

3. An application under Regulation 1 or 2 shall—

- (a) in the case of an application for registration as a butter manufacturer, cheese manufacturer, process cheese manufacturer, condensed milk manufacturer or milk powder manufacturer, be in the form specified in Annexure A hereto;
- (b) in the case of an application for registration as a farm cheese maker, be in the form specified in Annexure B hereto; and
- (c) in the case of an application for registration as a farm dairy butter maker, be in the form specified in Annexure C hereto,

and shall, in the case of an application for the renewal of any registration, be accompanied by the certificate of registration in respect of which the renewal is desired.

4. Any certificate of registration in respect of which renewal is not desired, shall upon its expiration be returned to the Board by the holder thereof.

5. Whenever the Board has cancelled any certificate of registration, that certificate shall be returned to the Board by the holder thereof immediately upon receipt of advice of such cancellation.


