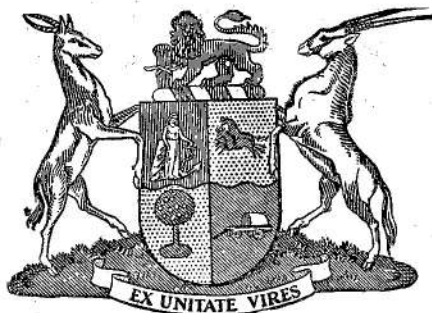

PROCLAMATION

BY HIS EXCELLENCY THE RIGHT HONOURABLE SIR PATRICK DUNCAN, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, KNIGHT GRAND CROSS OF THE MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE, ONE OF HIS MAJESTY'S COUNSEL LEARNED IN THE LAW, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

Whereas it has been notified to me that a vacancy has occurred in the representation of the Electoral Division of Orange Grove in the House of Assembly, by reason of the resignation of Mr. Colin Bain-Marais;

Now, therefore, under and by virtue of the powers and authority vested in me by sections *thirty-six* and *fifty-eight* of the Electoral Act, 1918 (No. 12 of 1918), I do hereby proclaim, declare and make known as follows—

- (1) that a vacancy exists in the representation of the Electoral Division of Orange Grove in the House of Assembly;
- (2) that a Nomination Court shall sit on Wednesday, the 3rd day of January, 1940, at ten o'clock in the forenoon, in Room No. 28, Old Post Office Buildings, Rissik Street, Johannesburg, to receive nominations of candidates for election to fill the said vacancy;
- (3) that if a poll becomes necessary in the Electoral Division aforesaid for the reason that more than one person shall have been duly nominated at the close of the sitting of the said Nomination Court, the said poll shall be taken on Wednesday, the 24th day of January, 1940, and will commence at seven o'clock in the morning and will close at eight o'clock in the evening of the said day; and
- (4) that the Electoral Officer, Johannesburg, or other person lawfully acting for him, shall be and is hereby appointed to be Returning Officer at the election in the said Division, to fill the said vacancy.

Nademaal ek in kennis gestel is dat 'n vakature ontstaan het in die verteenwoordiging van die kiesafdeling Orange Grove in die Volksraad weens die bedanking van die heer Colin Bain-Marais;

So is dit dat ek, kragtens die bevoegdheid my verleen by artikels *ses-en-dertig* en *ag-en-vyftig* van die Kieswet, 1918 (No. 12 van 1918), hierby proklameer, verklaar en bekend-maak as volg:—

- (1) dat 'n vakature in die verteenwoordiging van die kiesafdeling Orange Grove in die Volksraad bestaan;
- (2) dat 'n nominasiehoofsitting gehou word op Woensdag, 3 Januarie 1940, om tien-uur in die voormiddag, in Kamer No. 28, Ou Poskantoorgebou, Rissikstraat, Johannesburg, ten einde nominasies te ontvang van kandidate vir verkiesing om gemelde vakature te vul;
- (3) dat indien 'n stemming nodig word in genoemde kiesafdeling deurdat meer as een persoon by die sluiting van die sitting van voormelde nominasiehof behoorlik genomineer is, genoemde stemming op Woensdag, 24 Januarie 1940, plaasvind en om sewe-uur in die more begin en om agt-uur in die aand van genoemde dag sluit; en
- (4) dat die Verkiesingsbeampte, Johannesburg, of 'n ander persoon wat wettiglik namens hom optree, by die verkiesing in genoemde kiesafdeling om gemelde vakature te vul, hierby tot Kiesbeampte benoem word.
