BYLAE.

Die volgende nuwe regulasie moet na regulasie 33 ingevoeg word:—

DISSIPLINE.

34. Alle lede van die Kusgarnisoens- en Aktiewe Burgermag wat in diens geneem is en voltyds diens doen is aan dieselfde dissipline onderworpe as die waar aan lede van die Suid-Afrikaanse Staande Mag ingevolge die bepalings van die „Zuid Afrika Verdedigings Wet”, No. 13 van 1912, onderworpe is.

BY HIS EXCELLENCE THE RIGHT HONOURABLE SIR PATRICK DUNCAN, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, KNIGHT GRAND CROSS OF THE MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE, ONE OF HIS MAJESTY'S COUNSEL LEARNED IN THE LAW, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

Whereas by Proclamation No. 201 of 1939 the National Emergency Regulations, set forth in the Annexure to that Proclamation, were brought into operation;

And whereas it is expedient that the said Regulations be amended to make provision for the discipline of all members of the Coast Garrison and Active Citizen Forces who are employed on full-time service;

Now, therefore, I do hereby proclaim, declare and make known that the said Regulations are hereby amended as indicated in the Annexure to this Proclamation.

The following new regulation is inserted after regulation 33:—

DISCIPLINE.

34. All members of the Coast Garrison and Active Citizen Forces, who have been engaged for, and are employed on whole-time service, shall be subject to the same discipline as that to which members of the South African Permanent Force are subject under the South Africa Defence Act, No. 13 of 1912.

LEVY ON CONDENSING MILK.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), I, WILLIAM RICHARD COLLINS, Minister of Agriculture and Forestry, hereby make known that the Dairy Industry Control Board referred to in section *three* of the Dairy Products Marketing Scheme published under Proclamation No. 112 of 1939, has, in terms of section *twenty-six* of that Scheme, and with my approval, imposed the levy specified in the Schedule hereto.

And I do hereby further make known that the said levy shall become operative from the date of publication hereof.

SCHEDULE.

There is hereby imposed a levy of one halfpenny on every 25 gallons, or part thereof, of condensing milk purchased or otherwise acquired by a condensing milk manufacturer.
