

Hierby word bekendgemaak dat dit Sy Eksellensie die Goewerneur-generaal behaag het om sy goedkeuring te heg aan onderstaande wet wat hiermee, vir algemene informasie, gepubliseer word:—

ACT

To apply a further sum not exceeding one million seven hundred thousand eight hundred and eighty-six pounds towards the service of the Union for the year ending on the thirty-first day of March, 1940.

*(Signed by the Governor-General in Afrikaans.)
(Assented to 20th February, 1940.)*

BE IT ENACTED by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with £998,698 on revenue account.

Exchequer Account charged with £702,188 on loan account.

How money to be applied.

Minister may authorize variation.

Short title.

1. The Exchequer Account is hereby charged with such sums of money as may be required for the service of the Union (and chargeable to revenue account), during the year ending on the thirty-first day of March, 1940, not exceeding in the whole the sum of nine hundred and ninety-eight thousand six hundred and ninety-eight pounds, in addition to the sums charged by the Appropriation Act, 1939 (Act No. 31 of 1939).

2. The Exchequer Account is further charged with such sums of money as may be required for the service of the Union (and chargeable to loan account), during the year ending on the thirty-first day of March, 1940, not exceeding in the whole the sum of seven hundred and two thousand one hundred and eighty-eight pounds, in addition to the sums charged by the Appropriation Act, 1939 (Act No. 31 of 1939).

3. The money appropriated by this Act shall be applied to the services detailed in the Schedule hereto, and more particularly specified in the Estimates of Additional Expenditure [U.G. 2—1940], as approved by Parliament, and to no other purpose.

4. With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same vote: Provided that no excess shall be incurred on the sums appearing in column 2 of the Schedule hereto, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedule.

5. This Act shall be known as the Additional Appropriation Act, 1940.

Tot aanwending van 'n verdere som van nie meer as een-miljoen sewehonderd huisend agthonderd ses-en-tigtyg pond vir die diens van die Unie vir die jaar wat eindig op die een-en-dertigste dag van Maart 1940.

(Deur die Goewerneur-generaal in Afrikaans geteken.)
(Goedgekeur op 20 Februarie 1940.)

DIT WORD BEPAAL deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg :—

1. Die Skatkisrekening word hiermee belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die inkomsterekening), gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1940, maar gesamentlik nie meer as neghonderd agt-en-neëntig huisend seshonderd agt-en-neëntig pond, buite en behalwe die somme uitgetrek kragtens die Begrotingswet, 1939 (Wet No. 31 van 1939).

2. Die Skatkisrekening word verder belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die leningsrekening), gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1940, maar gesamentlik nie meer as sewehonderd en twee huisend eenhonderd agt-en-tagtyg pond, buite en behalwe die somme uitgetrek kragtens die Begrotingswet, 1939 (Wet No. 31 van 1939).

3. Die geld deur hierdie Wet beskikbaar gestel, moet aan-
gewend word vir die dienste opgenoem in die aangehegte
Bylae en met meer besonderhede vermeld in die Begroting
van Addisionele Uitgawes [U.G. 2—1940], soos deur die
Parlement goedgekeur, en vir geen ander doel.

4. Met die goedkeuring van die Minister van Finansies mag 'n besparing onder die een sub-hoof van 'n begrotingspos aangewend word tot dekking van te grote uitgawe onder 'n ander sub-hoof of van uitgawe onder 'n nuwe sub-hoof van dieselfde begrotingspos : Met die verstande dat die somme wat voorkom in kolom 2 van die Bylae tot hierdie Wet nie oorskry mag word nie en daarop gemaakte besparings ewemin aangewend mag word vir enige ander doel as waarvoor die geld hierby toegestaan word soos aangedui in die gemelde Bylae.

5. Hierdie Wet heet die Addisionele Begrotingswet, 1940. Kort titel.
