PROCLAMATION

By His Excellency the High Commissioner.

Whereas it is desirable to make further provision out of the public revenue or other funds of Basutoland to meet certain additional expenditure incurred during the year which ended the 31st day of March, 1939;

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

Additional appropriation.

1. The public revenue or other funds of Basutoland are hereby charged with a further sum of £21,451. 3s. 6d. (Twenty-one thousand four hundred and fifty-one pounds three shillings and sixpence) to meet expenditure incurred during the year ended the 31st day of March, 1939, in excess of the amounts appropriated for that purpose, according to the particulars set forth in the Schedule to this Proclamation.

Short title and commencement. 2. This Proclamation may be cited as the Basutoland Further Appropriation (1938-1939) Proclamation, 1940, and shall have force and take effect from the date of its publication in the Gazette.
