## PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable further to amend the Basutoland Prisons Proclamation, 1917, hereinafter referred to as "the principal law":

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

Amendment of Section 16A of the Basutoland Prisons (Further Amendment) Proclamation No. 21 of 1917.

1. Sub-section (1) of section *sixteen A* of the principal law, as enacted by the Basutoland Prisons (Further Amendment) Proclamation, 1937, and as amended by the Basutoland Prisons (Further Amendment) Proclamation, 1939, is hereby further amended by deleting the words "without having committed any prison offence during the last year".

Short title and commencement.

2. This Proclamation may be cited as the Basutoland Prisons (Amendment) Proclamation, 1940, and shall have force and take effect from the date of publication in the *Gazette*.

## BECHUANALAND PROTECTORATE.

### HIGH COMMISSIONER'S NOTICE

#### Areas

- that portion of the Ghanzi District which lies to the West of the 21st meridian of East longitude and South of latitude  $22^{\circ} 30'$ ;
- the whole of the Kgalagadi District.
