Now, therefore, under and by virtue of the powers and authorities vested in me by section *twenty-five* of the Native Administration Act, 1927 (Act No. 38 of 1927), I do hereby proclaim, declare and make known that, from and after the date of promulgation hereof, the said Proclamation No. 123 of 1931, as amended by Proclamation No. 234 of 1938, shall be further amended as follows:—

I. By the deletion of section *twenty-one* and the substitution therefor of the following new section:—

“21. Any person commits a breach of these regulations—

- (i) who, without having been duly authorised thereto either under these regulations or any other law,
 - (a) erects, establishes, occupies or uses any building or homestead on commonage;
 - (b) encloses, ploughs, cultivates or breaks up commonage otherwise than for burying dead bodies or refuse;
 - (c) encamps, takes up his abode or occupies commonage for any purpose whatsoever;
- (ii) who, contrary to the provisions of these regulations, causes damage to land, whether by neglecting to fill in any excavation or furrow or otherwise, when removing improvements in terms of section *thirteen*;
- (iii) who disregards or fails to comply with any order or finding made under the provisions of sub-section (3) of section *three*.”

II. By the insertion of the words “established, occupied or used” between the words “erected” and “without authority” in section *twenty-two*.

ESTABLISHMENT OF A PERIODICAL COURT AT DEVON IN THE DISTRICT OF NIGEL.

Whereas a Periodical Court was established at Devon in the Magisterial District of Heidelberg by Proclamation No. 16 of 1926 as varied by Proclamation No. 196 of 1933:

And whereas a separate Magisterial District Nigel was created by Proclamation No. 301 of 1939:

And whereas as a result of the said creation of Nigel as a separate Magisterial District, Devon aforesaid is now situate in the District of Nigel:

Now therefore, under and by virtue of the powers in me vested by paragraphs (f) and (h) of section *two* of the Magistrates' Courts Act 1917 (Act No. 32 of 1917), I do hereby appoint Devon in the District of Nigel, Province of the Transvaal, as a place for the holding of a Periodical Court, and prescribe that the local limits within which such Periodical Court shall have jurisdiction shall be as defined in the Schedule attached hereto.

Proclamation No. 16 of 1926 as varied by Proclamation No. 196 of 1933 is hereby cancelled.

SCHEDULE.

AREA OF JURISDICTION OF THE PERIODICAL COURT AT DEVON.

Beginning at the north-western beacon of the farm Het Blok No. 31, Nigel Magisterial District; proceeding thence generally eastwards along the northern boundary of the said farm Het Blok No. 31 and along the boundaries of and including the following farms in Springs Magisterial District: Syferfontein No. 33, Puntstaan No. 15, Goedehoop No. 24, Couwenburg No. 16, Enkeldebosch No. 43, Steenkoolspruit No. 50 and the following farms in Bethal Magisterial District: Springboklaagte No. 1 and Weltevreden No. 2 to the north-eastern beacon of the last-named farm; thence generally southwards and south-westwards along the boundaries of and including the following farms in Bethal Magisterial District: Weltevreden No. 2, Blesbokspruit No.

So is dit dat ek, kragtens die bevoegdheid my verleen by artikel *vyf-en-twintig* van die Naturelleadministrasie Wet, 1927 (Wet No. 38 van 1927), hiery proklameer, verklaar en bekendmaak dat, vanaf en na die datum van uitvaardiging hiervan, genoemde Proklamasie No. 123 van 1931, soos gewysig by Proklamasie No. 234 van 1938, as volg verder gewysig sal word:—

I. Deur die skrapping van artikel *een-en-twintig* en die vervanging daarvan deur die volgende nuwe artikel:—

„21. Iedereen begaan 'n oortreding van hierdie regulasies—

- (i) wat, sonder dat hy ingevolge hierdie regulasies of kragtens enige ander wet behoorlik daartoe gemagtig is,
 - (a) 'n gebou of woonhuis op die gemeentegrond oprig, daarstel, bewoon of gebruik;
 - (b) die gemeentegrond omhein, omploeg, bewerk of opbreek op ander wyse as vir die begrawe van dooie liggame of vuilgoed;
 - (c) uitkamp, vertoef of gebruik maak van gemeentegrond vir watter doel ook;
- (ii) wat, in stryd met die bepalinge van hierdie regulasies, grond beskadig, hetsy deur versuim om uitgrawings of watervore op te yul, hetsy op 'n ander manier by die wegruiming van aangebragte verbeterings ingevolge artikel *dertien*;
- (iii) wat enige bevel of uitspraak wat kragtens die bepalinge van subartikel (3) van artikel *drie* uitgevaardig of gedoen word, veronagsaam of 'n gebreke bly om dit na te kom.”

II. Deur die invoeging van die woorde „daarstel, bewoon of gebruik” tussen die woorde „opgerig” en „is” in artikel *twee-en-twintig*.
