

GOVERNMENT NOTICE

DEPARTMENT OF COMMERCE AND INDUSTRIES.

The following Government Notice is published for general information:—

NATIONAL EMERGENCY REGULATIONS.—CONTROL
OF TRADING WITH THE ENEMY.

Whereas the Government of the United Kingdom of Great Britain and Northern Ireland has from time to time compiled and published lists of persons and firms carrying on business in neutral countries, who have been proved to be enemies of His Majesty the King (or to be associated with such enemies) and with whom persons in the United Kingdom are therefore prohibited from trading, except with special permission from the said Government;

And whereas it is desirable that the Government of the Union of South Africa co-operate with the Government of the said United Kingdom in prohibiting dealings between any of His Majesty's subjects and His enemies;

Now, therefore, I, RICHARD STUTTAFORD, in my capacity of Minister of Commerce and Industries, by virtue of the powers vested in me by sub-regulation (3) of Regulation 8bis of the National Emergency Regulations promulgated in Proclamation No. 334, dated 22nd December, 1939, hereby—

- (a) prohibit any person from importing into, or receiving in the Union of South Africa or the Mandated Territory of South West Africa, any goods consigned by or on behalf of any person or firm whose name appears on the list set forth in the Annexure to this notice (which is a consolidation of the lists mentioned hereinbefore);
- (b) prohibit any person in the said Union or Territory from ordering any goods from any such person or firm as aforesaid;
- (c) prohibit any person from exporting or consigning any goods from the said Union or Territory to any such person or firm as aforesaid,

except with the permission, in writing, granted by myself or by an official whom I have authorised to grant such permission, which permission will be granted only in very exceptional cases; provided that the prohibition set forth in paragraph (a) shall not apply to the importation or receipt

DEPARTEMENT VAN HANDEL EN NYWERHEID.

Onderstaande Goewermentskennisgewing word vir algemene informasie gepubliseer:—

LANDSNOODTOESTAND-REGULASIES.—BEHEER
VAN HANDEL MET DIE VYAND.

Nademaal die Regering van die Verenigde Koninkryk van Groot-Brittannie en Noord-Ierland van tyd tot tyd lyste opgestel en gepubliseer het van persone en firmas wat in neutrale lande besigheid drywe en wat bewese vyande van Sy Majesteit die Koning is (of wat met sodanige vyande in verbinding staan), en met wie dit derhalwe vir persone in die Verenigde Koninkryk verbode is om handel te dryf, behalwe met spesiale vergunning van die genoemde Regering;

En nademaal dit wenslik is dat die Regering van die Unie van Suid-Afrika met die Regering van die genoemde Verenigde Koninkryk saamwerk om transaksies tussen enige van Sy Majesteit se onderdaane en Sy vyande te belet;

So is dit dat ek, RICHARD STUTTAFORD, in my hoedanigheid as Minister van Handel en Nywerheid en kragtens die bevoegdheid my verleen by subregulasié (3) van regulasié 8bis van die Landsnoodtoestand-regulasié, uitgevaardig in Proklamasie No. 334, gedateer 22 Desember 1939, hierby—

- (a) enige verbod om enige goedere, versend deur of ten behoeve van enige persoon of firma wie se naam in die lys uiteengestel in die bylae van hierdie kennisgewing (wat 'n samevatting is van die lyste, voorheen genoem) verskyn, in te voer na of in die Unie van Suid-Afrika of die Mandaatgebied Suidwes-Afrika te ontvang;
- (b) enigeen in die genoemde Unie of Mandaatgebied verbod om enige goedere van enige sodanige persoon of firma soos voormeld te bestel;
- (c) enigeen verbod om enige goedere van die genoemde Unie of Mandaatgebied na enige sodanige persoon of firma soos voormeld uit te voer of te versend.

Behalwe met skriftelike vergunning deur myself verleen of deur 'n beampie deur my gemagtig om sodanige vergunning te verleen, en welke vergunning slegs in uitsonderlike gevalle verleen sal word; met dien verstande dat die verbod uiteengestel in paragraaf (a) nie van toepassing sal wees nie op

of goods for which the importer or recipient paid or which were despatched by the person or firm from whom they were ordered—

- (i) on or before the 5th January, 1940, if the goods in question were obtained or ordered from a person or firm whose name on the list set forth in the Annexure to this notice is not preceded by a numeral;
- (ii) on or before the 30th January, 1940, if the goods in question were obtained or ordered from a person or firm whose name on the said list is preceded by the numeral¹;
- (iii) on or before the 8th March, 1940, if the goods in question were obtained or ordered from a person or firm whose name on the said list is preceded by the numeral²;
- (iv) on or before the date of publication of this notice in the *Government Gazette* if the goods in question were obtained or ordered from a person or firm whose name on the said list is preceded by the numeral³;

and provided, further, that the prohibition set forth in paragraph (c) shall not apply to the export or consignment of goods which were lawfully placed on rail or on board ship for export, on or before the date of publication of this notice in the *Government Gazette*;

And by virtue of the powers conferred upon me as aforesaid, I further declare that any goods which have been imported or received, or which have been exported or consigned in contravention of the prohibition set forth above shall be forfeited to the State and shall be dealt with as I shall direct, and that any person who contravenes or attempts to contravene the prohibition set forth above, shall be guilty of an offence and liable to a fine not exceeding two hundred pounds or to imprisonment during a period not exceeding one year or to both such fine and imprisonment.

I hereby withdraw Government Notices No. 151 of 1940 and No. 349 of 1940 (which were published in the *Government Gazette* on the 30th January, 1940, and the 8th March, 1940, respectively), as from the date of publication of this notice in the *Government Gazette*.

- (i) op of voor 5 Januarie 1940, indien die betrokke goedere verkry of bestel is van 'n persoon of firma wie se naam nie deur 'n nommer op die lys uiteengesit in die bylae van hierdie kennisgewing voorafgegaan word nie;
- (ii) op of voor 30 Januarie 1940, indien die betrokke goedere verkry of bestel is van 'n persoon of firma wie se naam op die genoemde lys deur die nommer¹ voorafgegaan word;
- (iii) op of voor 8 Maart 1940, indien die betrokke goedere verkry of bestel is van 'n persoon of firma wie se naam op die genoemde lys deur die nommer² voorafgegaan word;
- (iv) op of voor die datum van publikasie van hierdie kennisgewing in die *Staatskoerant*, indien die betrokke goedere verkry of bestel is van 'n persoon of firma wie se naam op die genoemde lys deur die nommer³ voorafgegaan word;

en met dien verstande verder dat die verbod uiteengesit in paragraaf (c) nie van toepassing sal wees nie op die uitvoer of versending van goedere wat wettiglik vir uitvoer op 'n trein of aan boord skip geplaas was op of voor die datum van publikasie van hierdie kennisgewing in die *Staatskoerant*;

En kragtens die bevoegdheid my verleent soos voormeld, verstaan ek verder dat enige goedere wat in stryd met die verbod hierbo uiteengesit, ingevoer of ontvang, of uitgevoer of versend is, aan die Staat verbeurd verklaar sal word en mee gehandel sal word soos ek sal beveel, en dat enigeen wat die verbod hierbo uiteengesit, oortree of probeer oortree, 'n oortreding begaan en by veroordeling strafbaar sal wees met 'n boete van hoogstens tweehonderd pond, of met gevangenisstraf vir 'n tydperk van hoogstens een jaar, of met beide sodanige boete en gevangenisstraf.

Hierby trek ek Goewermentskennisgewing No. 151 van 1940 en No. 349 van 1940 (wat op 30 Januarie 1940, en 8 Maart 1940, respektiewelik, in die *Staatskoerant* gepubliseer is) terug vanaf die datum van publikasie van hierdie kennisgewing in die *Staatskoerant*.
