By HIS EXCELLENCE THE RIGHT HONOURABLE SIR PATRICK DUNCAN, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, KNIGHT GRAND CROSS OF THE MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE, ONE OF HIS MAJESTY'S COUNSEL LEARNED IN THE LAW, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

ATTACHMENT OF PERSONNEL AND MUTUAL POWERS OF COMMAND.

Under and by virtue of the powers vested in me by section ten, sub-section (4), of the Defence Act (Amendment) and Dominion Forces Act, 1932 (Act No. 32 of 1932), I do hereby proclaim, declare and make known that for the purposes of section ten of the said Act, a Union force, designated the Mobile Field Force, serving outside the limits of the Union of South Africa, is serving together or acting in combination with Dominion forces, that is to say with His Majesty's East African Forces.
