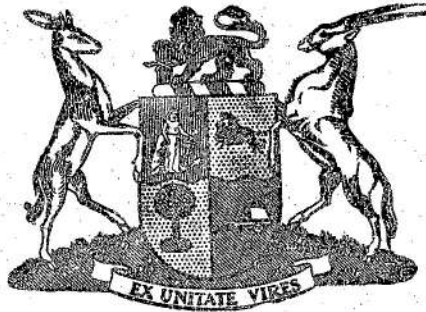

DEPARTEMENT VAN VERDEDIGING.

Onderstaande Goewermementskennisgewing word vir algemene informasie gepubliseer:—

* No. 1385.] [26 Augustus 1940.

Nademaal by Goewermementskennisgewing No. 1315 van 9 Augustus 1940 sekere persone wat in die Aanhangsel van vermelde Goewermementskennisgewing genoem is, verbied is om die Unie of die Mandaatgebied van Suidwes-Afrika sonder 'n permit te verlaat;

En nademaal dit wenslik is dat die aanhangsel van die genoemde Goewermementskennisgewing gewysig word;

So is dit dat ek kragtens die bevoegdheid wat aan my verleen is ingevolge regulasie 14 van die Landnoodtoestand-regulasies wat by Proklamasie No. 201 van 1939 geproklameer is en by artikel twee van „Die Wet op Oorlogsmaatreëls” 1940 geldig gemaak is, die Aanhangsel van Goewermementskennisgewing No. 1315 van 1940 wysig deur—

- (a) die woord „manlike” in artikel (1) (b) te skrap, en
- (b) subartikel (c) van artikel (1) daarvan te skrap.

GOVERNMENT NOTICE

DEPARTMENT OF DEFENCE.

The following Government Notice is published for general information:—

* No. 1385.] [26 August 1940.

Whereas by Government Notice No. 1315 of 1940, dated 9th August, 1940, certain persons mentioned in the Annexure to the said Government Notice were prohibited from leaving the Union or the Mandated Territory of South-West Africa except under the authority of a permit;

And whereas it is desirable that the annexure to the said Government Notice be amended;

Now, therefore, under and by virtue of the powers vested in me by Regulation 14 of the National Emergency Regulations, promulgated by Proclamation No. 201 of 1939, and validated by section two of the War Measures Act, 1940, I do hereby amend the Annexure to Government Notice No. 1315 of 1940 by—

- (a) deleting the word “male” in sub-paragraph (b) of paragraph (1) thereof;
- (b) deleting sub-paragraph (c) of paragraph (1) thereof.
