SPECIAL LEVIES ON CERTAIN DAIRY PRODUCTS.
In terms of sub-section (1) of section twenty-nine of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, WILLIAM RICHARD COLLINS, Minister of Agriculture and Forestry, hereby make known that the Dairy Industry Control Board, referred to in section 3 of the Dairy Products Marketing Scheme, published by Proclamation No. 199 of 1940, as amended, has, in terms of section 8bis of that Scheme, imposed the special levies mentioned in the Schedule hereto.

And I do hereby further make known that the said special levies shall become operative on the first day of November, 1942.

SCHEDULE.

There is hereby imposed, in substitution for the special levy made known by Government Notice No. 172 of the 30th January, 1942, a special levy—

- (a) in the case of creamery butter, at a rate of four-tenths of one penny per pound; and
- (b) in the case of factory cheese, at a rate of four-tenths of one penny per pound.

The said levies shall become operative on the first day of November, 1942.

In terms of sub-section (1) of section twenty-nine of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, WILLIAM RICHARD COLLINS, Minister of Agriculture and Forestry, hereby make known that the Dairy Industry Control Board, referred to in section 3 of the Dairy Products Marketing Scheme, published by Proclamation No. 199 of 1940, as amended, has, in terms of section 12 of that Scheme, amended the prohibitions made known by Government Notice No. 182 of 1942, in the manner indicated in the Schedule hereto.

And I do hereby further make known that the said amendments shall become operative on the first day of November, 1942.

En ek maak hierby verder bekend dat genoemde wysigings op die eerste dag van November 1942 van krag word.

SCHEDULE.

The prohibitions imposed in connection with the sale of certain dairy products and made known in the Schedule to Government Notice No. 182 of the 30th January, 1942, are hereby amended—

(a) by the substitution for clause 1 of the following clause:—

“1. No producer of factory cream shall sell any such cream otherwise than on the basis of its butterfat-content or at a price other than—

- (a) one shilling and sixpence per pound for first grade butterfat contained therein;
- (b) one shilling and four pence per pound for second grade butterfat contained therein; or
- (c) one shilling and two pence per pound for third grade butterfat contained therein;”

(b) by the substitution for clause 4 of the following clause:—

“4. No producer of cheesemilk shall sell any such milk at a price other than—

- (a) nine pence per gallon if such milk is sold by the gallon; or
- (b) two shillings and one penny per pound butterfat contained therein if such milk is bought on the basis of its butterfat-content:

Provided that this prohibition shall not apply to the sale of cheesemilk, for educational purposes, to a Government controlled Institution;”

(c) by the substitution for clause 7 of the following clauses:—

“Condensing Milk Prices.

7. No producer of condensing milk shall sell any such milk at a price other than—

- (a) ten pence per gallon if such milk is purchased by the gallon; or
- (b) two shillings and four pence per pound butterfat contained therein if such milk is bought on the basis of its butterfat-content.

Conditions attached to the Prices of Butterfat, Cheesemilk and Condensing Milk.

8. The following conditions shall attach to the prices fixed for the purpose of the prohibitions imposed under clauses 1, 4 and 7, viz.—

(a) that any amount payable to a producer of factory cream, cheesemilk or condensing milk in respect of such cream or milk, as the case may be, sold by him, shall be reduced by any railage or other transport charges which the purchaser may have paid on or incurred in connection with the transport of such cream or milk; provided that such other transport charges shall not be less than the rates charged by the South African Railways and Harbours Administration for similar services in respect of cream;

(b) that payment of the amount due to a producer in respect of factory cream, cheesemilk or condensing milk sold by him shall be effected not later than the fifteenth day of the calendar month following that in which the cream or milk was sold by him”;

numbering the existing clauses 8 and 9 as 9 and 10, respectively.

BYLAE.

Die verbodsbeplings opgelê in verband met die verkoop van sekere suiwelprodukte en aangekondig in die bylae tot Goewermentskennisgewing No. 182 van 1942, word hiermee gewysig—

(a) deur klosule 1 te vervang deur die volgende klosule:—

“1. Geen fabrieksroomprodusent mag sodanige room verkoop nie, andersins as op die basis van die bottervetgehalte daarvan of teen 'n ander prys as—

- (a) een sjeling en ses pennies per pond vir eerstegraad-bottervet daarin;
- (b) een sjeling en vier pennies per pond vir tweedegraad-bottervet daarin; of
- (c) een sjeling en twee pennies per pond vir derdegraad-bottervet daarin.”;

(b) deur klosule 4 te vervang deur die volgende klosule:—

“4. Geen kaasmelkprodusent mag sodanige melk verkoop nie teen 'n ander prys as—

- (a) nege pennies per gallon indien sodanige melk per gallon gekoop word; of
- (b) twee sjelings en een pennie per pond bottervet daarin bevat, indien sodanige melk op die basis van sy bottervetgehalte gekoop word:

Met dien verstande dat hierdie verbod nie op die verkoop van kaasmelk, vir opvoedkundige doeleindes, aan 'n Staatsbeheerde instigting van toepassing is nie.”;

(c) deur klosule 7 te vervang deur die volgende klosules:—

„Kondenseermelkpryse.

7. Geen kondenseermelkprodusent mag sodanige melk verkoop nie teen 'n ander prys as—

- (a) tien pennies per gallon indien sodanige melk per gallon gekoop word; of
- (b) twee sjelings en vier pennies per pond bottervet daarin bevat, indien sodanige melk op die basis van sy bottervetgehalte gekoop word.”

„Voorwaardes geheg aan die pryse van bottervet, kaasmelk en kondenseermelk.

8. Die volgende voorwaardes is geheg aan die pryse vasgestel vir die doeleindes van die verbod opgelê in klosules 1, 4 en 7, naamlik:

(a) Dat 'n bedrag betaalbaar aan 'n fabrieksroom-, kaasmelk- of kondenseermelkprodusent ten opsigte van sodanige room of melk, al na die gevall mag wees, deur hom verkoop, verminder moet word met enige spoorvrag of ander vervoerkoste wat die koper mag betaal of beloop het in verband met die vervoer van sodanige room of melk; met dien verstande dat sodanige ander vervoerkoste nie minder mag wees nie as die tariewe deur die Suid-Afrikaanse Spoorweg- en Hawensadministrasie vir dergelyke dienste ten opsigte van room bereken;

(b) dat betaling van die bedrag aan 'n produsent verskuldig ten opsigte van fabrieksroom, kaasmelk of kondenseermelk deur hom verkoop, nie later as die vyftiende dag van die kalendermaand wat volg op dié waarin die room of melk verkoop was, mag geskied nie.”; en

(d) deur die bestaande klosules 8 en 9 as 9 en 10 onderskeidelik te nommer.
