

PRICE CONTROL—MAXIMUM PRICES OF SPIRITS,
BEER, CIGARETTES AND TOBACCO.

1. In terms of Regulation 3 of War Measure No. 100 of 1942, I, EDWARD JAMES CREAN, Price Controller, do hereby, throughout the Union, fix the current prices plus the additions specified in the Schedule hereto as the maximum prices at which any of the goods specified in the said Schedule may be sold by a dealer to a person who is not a dealer.

PRYSBEHEER—MAKSIMUM PRYSE VAN SPIRITU-

1. Ek, EDWARD JAMES CREAN, Pryskontroleur, handelende kragtens Regulasie 3 van Oorlogsmaatreël No. 100 van 1942 bepaal hierby, vir die hele Unie, dat die huidige prys vermeerder met die bedrae, wat in bygaande lys uiteengesit is, die maksimum prys is waarteen enige goedere soos in genoemde lys uiteengesit deur 'n handelaar aan 'n persoon wat nie 'n handelaar is nie, verkoop mag word.

2. For the purposes of this notice—

“current prices” means in relation to any dealer the prices at which during the week ended 20th February, 1943, it was permissible under the provisions of War Measure No. 100 of 1942 or any relevant notice issued under the said War Measure for him to sell any of the goods specified in the Schedule hereto to a person other than a dealer; and

“Union” includes the mandated territory of South-West Africa and the port and settlement of Walvis Bay.
