

Hierby word bekendgemaak dat dit Sy Eksellensie die Amptenaar Belas met die Uitoefening van die Uitvoerende Gesag behaag het om sy goedkeuring te heg aan onderstaande wet, wat hierby, ter algemene inligting, gepubliseer word:—

**ACT**

**To apply a further sum not exceeding three million one hundred and thirty-eight thousand eight hundred and nine pounds towards the service of the Union for the year ending on the thirty-first day of March, 1943.**

*(Signed by the Officer Administering the Government in Afrikaans.)*

*(Assented to 17th March, 1943.)*

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with £2,258,209 on revenue account.

1. The Exchequer Account is hereby charged with such sums of money as may be required for the service of the Union (and chargeable to revenue account) during the year ending on the thirty-first day of March, 1943, not exceeding in the whole the sum of two million two hundred and fifty-eight thousand two hundred and nine pounds, in addition to the sums with which that Account has been charged by the Appropriation Act, 1942 (Act No. 37 of 1942) and the Additional Appropriation Act, 1943 (Act No. 1 of 1943).

Exchequer Account charged with £880,600 on loan account.

2. The Exchequer Account is further charged with such sums of money as may be required for the service of the Union (and chargeable to loan account) during the year ending on the thirty-first day of March, 1943, not exceeding in the whole the sum of eight hundred and eighty thousand six hundred pounds, in addition to the sums with which that Account has been charged by the Appropriation Act, 1942 (Act No. 37 of 1942) and the Additional Appropriation Act, 1943 (Act No. 1 of 1943).

How money to be applied.

3. The money appropriated by this Act shall be applied to the services detailed in the Schedule hereto, and more particularly specified in the Second Estimates of Additional Expenditure [U.G. 15—1943] as approved by Parliament, and to no other purpose.

Minister may authorize variation.

4. With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same vote: Provided that no excess shall be incurred on the sums appearing in column 2 of the Schedule hereto, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedule.

Short title.

5. This Act shall be known as the Second Additional Appropriation Act, 1943.

**DIT WORD BEPAAL** deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg:—

1. Die Skatkisrekening word hiermee belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die inkomsterekening) gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1943, maar gesamentlik nie meer nie as tweemiljoen tweehonderd-ag-en-vyftigduisend tweehonderd-en-nege pond, benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1942 (Wet No. 37 van 1942) en die Addisionele Begrotingswet, 1943 (Wet No. 1 van 1943) belas is. Die Skatkisrekening word verder belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die leningsrekening) gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1943, maar gesamentlik nie meer nie as aghonderd-en-tagtig duisend seshonderd pond, benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1942 (Wet No. 37 van 1942) en die Addisionele Begrotingswet, 1943 (Wet No. 1 van 1943) belas is. Skatkisrekening

3. Die geld deur hierdie Wet beskikbaar gestel, moet aangewend word vir die dienste opgenoem in die aangehegte Bylae en met meer besonderhede vermeld in die Tweede Begroting van Addisionele Uitgawes [U.G. 15—1943], soos deur die Parlement goedgekeur, en vir geen ander doel. Hoe die geld  
bestee moet word.
4. Met die goedkeuring van die Minister van Finansies mag 'n besparing onder die een sub-hoof van 'n begrotingspos aangewend word tot dekking van te grote uitgawe onder 'n ander sub-hoof of van uitgawe onder 'n nuwe sub-hoof van dieselfde begrotingspos: Met dien verstande dat die somme wat voorkom in kolom 2 van die Bylae tot hierdie Wet nie oorskry mag word nie en daarop gemaakte besparings ewemin aangewend mag word vir enige ander doel as waarvoor die geld hierby toegestaan word soos aangedui in die gemelde Bylae.
