

ACT

To provide for the disposal of certain surplus State revenues and surplus revenues of the Railway and Harbour Fund ; to indemnify the South African Reserve Bank against loss in connection with certain advances ; to exempt certain councils and boards from the payment of certain taxes ; to provide that a portion of the sums expended on the Egmont irrigation works and the Schoonspruit irrigation works shall be a subsidy and for the writing off of a portion of the interest on the remainder ; to provide for the payment of certain allowances to the Controller and Auditor-General ; to provide for the reception in work colonies in the Union of persons from territories outside the Union ; to determine the date of disposition for the purposes of Act No. 32 of 1931 of the former general post office at Cape Town ; to validate certain payments to a member of the Tourist Development Corporation of Southern Africa ; and to amend Acts No. 10 of 1911, No. 32 of 1914, No. 20 of 1917, No. 36 of 1919, No. 41 of 1925, No. 37 of 1935, No. 36 of 1937, No. 16 of 1941 and No. 45 of 1941.

BE IT ENACTED by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows :—

Disposal of surplus State revenues.

1. The surplus State revenues in respect of the financial year ended on the thirty-first day of March, 1943, as certified by the Controller and Auditor-General, shall be paid to the credit of the Loan Account to an amount not exceeding one million five hundred thousand pounds.

Disposal of surplus revenue of Railway and Harbour Fund.

2. From the surplus revenue of the Railway and Harbour Fund in respect of the financial year ended on the thirty-first day of March, 1943, the following sums are hereby appropriated as hereunder provided :

(a) Five hundred thousand pounds shall be paid to the credit of the Administration's Betterment Fund.

(b) The remainder of the surplus as certified by the Controller and Auditor-General shall be credited to the Rates Equalization Fund, established under section *one hundred and twenty-eight* of the South Africa Act, 1909.

Indemnity to South African Reserve Bank in respect of certain losses.

3. (1) Any loss which may be incurred by the South African Reserve Bank in consequence of any liability assumed by it in connection with the matters set out in sub-section (3) shall, subject to the provisions of sub-section (2), be defrayed from the Consolidated Revenue Fund.

(2) The liability referred to in sub-section (1) shall, in regard to any of the matters mentioned in sub-section (3), be for an amount not exceeding an amount to be specified in a guarantee given by the Minister of Finance to the said Bank.

(3) The matters referred to in sub-section (1) shall be any advance made—

(a) to the Minister of Commerce and Industries in connection with the procurement of goods required in the Union ;

(b) to the Controller of Food Supplies referred to in the regulations published under War Measure No. 22 of 1942, in connection with the acquisition of any goods under the said regulations ;

(c) to the Minister of Commerce and Industries or the officer referred to in sub-regulation (1) of regulation 34 of the regulations published under War Measure No. 146 of 1942, for payment into the External Procurements Fund established by the said regulation ; and

(d) to the Director General of Supplies referred to in regulation 9 of the said regulations, in connection with any expenditure incurred by him under the said regulations which is not defrayable from the said Fund.

(4) Sub-sections (1) and (2) and paragraphs (a) and (b) of sub-section (3) shall be deemed to have come into operation on the first day of June, 1942, and paragraphs (c) and (d) of sub-section (3), shall be deemed to have come into operation on the first day of February, 1943.

Exemption of Glen Grey and certain other councils and boards from the payment of duty, fee or other tax.

4. No duty, fee or other tax imposed by or under any law (other than any law relating to customs or excise or to levies on agricultural products) shall be payable by the Glen Grey District Council, established under section *thirty-eight* of the

Om voorsiening te maak vir die besteding van sekere surplus-staats-inkomste en surplus-inkomste van die Spoorweg- en Hawefonds ; tot vrywaring van die Suid-Afrikaanse Reserwebank teen verlies in verband met sekere voorskotte ; om sekere rade van die betaling van sekere belastings vry te stel ; om voorsiening te maak dat 'n gedeelte van die bedrae aan die Egmont-besproeingswerke en die Schoonspruit-besproeingswerke bestee, 'n subsidie is, en vir afskrywing van 'n gedeelte van die rente op die restant ; om voorsiening te maak vir betaling van sekere toelaes aan die Kontroleur en Ouditeur-generaal ; om voorsiening te maak vir toelating van persone uit gebiede buite die Unie tot werkkolonies in die Unie ; om die datum van die van die handsetting van die gewese hoofposkantoor te Kaapstad, vir die doeleinde van Wet No. 32 van 1931 te bepaal ; tot wettiging van sekere betalings aan 'n lid van die Korporasie vir die Uitbreiding van Toeristeverkeer van die Suide van Afrika ; en tot wysiging van Wette No. 10 van 1911, No. 32 van 1914, No. 29 van 1917, No. 36 van 1919, No. 41 van 1925, No. 37 van 1935, No. 36 van 1937, No. 16 van 1941 en No. 45 van 1941.

DIT WORD BEPAAL deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg :—

1. Die surplus-staatsinkomste oor die boekjaar wat op die een-en-dertigste dag van Maart 1943 geëindig het, soos deur die Kontroleur en Ouditeur-generaal gesertifiseer, word, tot 'n bedrag van hoogstens eenmiljoen vyfhonderdduisend pond, na die Leningsrekening oorgedra.

2. Uit die surplus-inkomste van die Spoorweg- en Hawefonds oor die boekjaar wat op die een-en-dertigste dag van Maart 1943 geëindig het, word die volgende bedrae hereby beskikbaar gestel soos hieronder bepaal—

(a) vyfhonderdduisend pond word na die Administrasie se Verbeteringsfonds oorgedra ;

(b) die restant van die surplus soos deur die Kontroleur en Ouditeur-generaal gesertifiseer, word oorgedra na die Tariewereserwfonds kragtens artikel *honderd-agt-en-twintig* van die „Zuid-Afrika Wet, 1909” ingestel.

3. (1) Enige verlies wat deur die Suid-Afrikaanse Reserwebank gely word ten gevolge van aanspreeklikheid deur hom in verband met die in sub-artikel (3) vermelde aangeleenthede aanvaar, word, behoudens die bepalings van sub-artikel (2), uit die Gekonsolideerde Inkomstefonds bestry.

(2) Die in sub-artikel (1) bedoelde aanspreeklikheid word aanvaar, met betrekking tot enigeen van die in sub-artikel (3) vermelde aangeleenthede vir 'n bedrag wat nie meer beloop nie dan 'n bedrag te vermeld in 'n garansie deur die Minister van Finansies aan genoemde bank gegee.

(3) Die in sub-artikel (1) bedoelde aangeleenthede behels voorskotte verstrek—

(a) aan die Minister van Handel en Nywerheid in verband met die verkryging van in die Unie benodigde goedere ;

(b) aan die Kontroleur van Voedingsware vermeld in die regulasies gepubliseer kragtens Oorlogsmaatreël No. 22 van 1942, in verband met die verkryging van goedere kragtens genoemde regulasies ;

(c) aan die Minister van Handel en Nywerheid of die amptenaar vermeld in sub-regulasie (1) van regulasie 34 van die regulasies gepubliseer kragtens Oorlogsmaatreël No. 146 van 1942, ter storting in die Buite-landse Verkrygingsfonds deur genoemde regulasie ingestel ; en

(d) aan die Direkteur-generaal van Voorrade in regulasie 9 van genoemde regulasies vermeld, in verband met deur hom ingevolge genoemde regulasies opgelope onkoste wat nie uit genoemde Fonds bestry kan word nie.

(4) Sub-artikels (1) en (2) en paragrawe (a) en (b) van sub-artikel (3) word geag op die eerste dag van Junie 1942, en paragrawe (c) en (d) van sub-artikel (3) op die eerste dag van Februarie 1943, in werking te getree het.

4. Geen reg, geld of ander belasting opgelê deur of kragtens 'n wet (behalwe 'n wet met betrekking tot doeane of aksyns of tot heffings op landbouprodukte), is betaalbaar nie deur die „Glen Grey District Council”, ingestel kragtens artikel *agt-* Vrystelling van Glen Grey en sekere ander rade van betaling van regte, gelde of ander belastings.

Glen Grey Act, 1894 (Act No. 25 of 1894) of the Cape of Good Hope, any board of management nominated under section four of the Native Reserves Management Ordinance, 1907 (Ordinance No. 6 of 1907), of the Orange Free State, any general or local council, established under the Native Affairs Act, 1920 (Act No. 23 of 1920) or the United Transkeian Territories General Council or any district council referred to in Proclamation No. 191 of 1932.

Granting of subsidy on Egmont irrigation works and discharge of Egmont Irrigation Board from liability for certain interest charges.

5. A sum of fifty-four thousand four hundred and ninety pounds seventeen shillings and ten pence expended by the Government on the Egmont irrigation works in the district of Wepener in the Orange Free State, shall be a subsidy in respect of the said works and all interest accrued and accruing up to the thirtieth day of June, 1943, on the loan of eighteen thousand five hundred pounds granted by the Government to the Egmont irrigation board shall be written off.

Granting of subsidy on Schoonspruit irrigation works and discharge of Schoonspruit Irrigation Board from liability for certain interest charges.

6. A sum of twelve thousand nine hundred and one pounds eighteen shillings and eleven pence expended by the Government on the Schoonspruit irrigation works in the district of Ventersdorp in the Transvaal, shall be a subsidy in respect of the said works and all interest accrued and accruing up to the thirtieth day of June, 1943, on the loan of three thousand four hundred and forty-six pounds ten shillings and ten pence granted by the Government to the Schoonspruit irrigation board shall be written off.

Payment of allowances to the Controller and Auditor-General.

7. (1) In addition to the annual salary payable to the Controller and Auditor-General in terms of section five of the Exchequer and Audit Act, 1911 (Act No. 21 of 1911), there shall be paid to him such allowances as would have been payable to him if he had been an officer in the public service.

(2) Sub-section (1) shall be deemed to have come into operation on the thirtieth day of December, 1940.

Reception in work colonies in the Union of persons from territories outside the Union.

8. (1) The Governor-General may enter into an agreement with the head of the Government of any British territory in Africa south of the equator for the reception into and retention in any work colony in the Union of any person over the age of nineteen years whose detention in a work colony for a period of not less than one year has been ordered by a competent court of the said territory according to the law in force therein. When such agreement has been entered into, the Minister of Social Welfare shall publish in the *Gazette* a notice of that fact and a summary of the terms of the agreement.

(2) The Minister of Social Welfare may direct the reception and detention in a work colony of any person over the age of nineteen years whose detention in a work colony has been ordered by a competent court of a territory with the head of whose government the Governor-General entered into an agreement mentioned in sub-section (1).

(3) Any person who was received into a work colony by direction of the Minister of Social Welfare under sub-section (2) may be retained therein until the expiry of the period fixed by the court which ordered the said person's detention in a work colony, but not exceeding the period during which he could have been retained therein in accordance with the provisions of the Work Colonies Act, 1927 (Act No. 20 of 1927), if he had been sent to a work colony by order of a competent court in the Union.

(4) The relevant provisions of the said Act and of the regulations made thereunder shall apply to a person received into or detained in a work colony under the provisions of this section as if he had been sent to that work colony under the said Act.

Date of disposition for purposes of Act 32 of 1931, of former general post office at Cape Town.

9. For the purposes of sub-section (2) of section one of the State Property (Immunity from Rating) Act, 1931, the premises in Adderley Street, Cape Town, which were, prior to the fourteenth day of March, 1942, used as the general post office at Cape Town, shall be deemed to have been disposed of on the fourteenth day of March, 1942.

Validation of certain payment to member of Tourist Development Corporation of Southern Africa.

10. Notwithstanding the provisions of section six of the Tourist Development Corporation Act, 1938 (Act No. 15 of 1938), the payment made to Dr. A. J. Norval, a member of the board of control of the Tourist Development Corporation of Southern Africa established by section two of the said Act, of an amount of twenty-eight pounds seven shillings, in respect of his attendance at meetings of the said board during the period between the twenty-first day of May and the seventeenth day of November, 1939, is hereby validated.

Amendment of section 67 of Act 10 of 1911.

11. Section sixty-seven of the Post Office Administration and Shipping Combinations Discouragement Act, 1911, is hereby

'n Bedrag van vier-en-vyftigduisend vierhonderd-en-negentig pond sewentien sjielings en tien pennies wat deur die Regering bestee is aan die Egmont-besproeiingswerke in die distrik Wepener in die Oranje-Vrystaat, geld as 'n subsidie ten opsigte van genoemde werke en alle rente wat tot op die dertigste dag van Junie 1943 opgeloop het en oploop op die lening van agtienduisend vyfhonderd pond deur die Regering aan die Egmont-besproeiingsraad toegestaan, word afgeskryf.

6. 'n Bedrag van twaalfduisend neghonderd-en-een pond agtien sjielings en elf pennies wat deur die Regering bestee is aan die Schoonspruit-besproeiingswerke in die distrik Ventersdorp in die Transvaal, geld as 'n subsidie ten opsigte van genoemde werke en alle rente wat tot op die dertigste dag van Junie 1943 opgeloop het en oploop op die lening van drieduusend vierhonderd ses-en-veertig pond tien sjielings en tien pennies, deur die Regering aan die Schoonspruit-besproeiingsraad toegestaan, word afgeskryf.

7. (1) Benewens die jaarlike salaris wat ooreenkomsig artikel *vijf* van die „Financiewet, 1911” (Wet No. 21 van 1911) aan die Kontroleur en Ouditeur-generaal betaalbaar is, word daar aan hom sulke toelaes betaal as wat aan hom betaalbaar sou gewees het indien hy 'n amptenaar in die staatsdiens was.

(2) Sub-artikel (1) word geag op die dertigste dag van Desember, 1940, in werking te getree het.

8. (1) Die Goewerneur-generaal kan 'n ooreenkoms aanvaan met die hoof van die regering van 'n Britse gebied in Afrika besuide die ewenaar vir die opname en aanhouding in 'n werkkolonie in die Unie van iemand bo die leeftyd van negentien jaar wie se aanhouding in 'n werkkolonie vir 'n tydperk van minstens 'n jaar deur 'n bevoegde hof van genoemde gebied ooreenkomsig die aldaar geldende reg gelas is. Wanneer so 'n ooreenkoms aangegaan is, laat die Minister van Volkswelsyn 'n kennisgewing daarvan en 'n opsomming van die voorwaardes van die ooreenkoms in die *Staatskoerant* verskyn.

(2) Die Minister van Volkswelsyn kan gelas dat iemand bo die leeftyd van negentien jaar wie se aanhouding in 'n werkkolonie gelas is deur 'n bevoegde hof van 'n gebied met die hoof van die regering waarvan die Goewerneur-generaal 'n in sub-artikel (1) vermelde ooreenkoms aangegaan het, in 'n werkkolonie opgeneem en aangehou word.

(3) Iemand wat op las van die Minister van Volkswelsyn kragtens sub-artikel (2) in 'n werkkolonie opgeneem is, kan daarin aangehou word tot na verstryking van die tydperk bepaal deur die hof wat die aanhouding van so iemand in 'n werkkolonie gelas het dog nie langer nie as die tydperk waarvoor hy ooreenkomsig die bepalings van die Werkkolonies-wet, 1927 (Wet No. 20 van 1927) daarin aangehou sou kon geword het, indien hy op las van 'n bevoegde hof in die Unie na 'n werkkolonie gestuur was.

(4) Die toepaslike bepalings van genoemde Wet en van die ingevolge daarvan uitgevaardigde regulasies, is van toepassing op iemand wat kragtens die bepalings van hierdie artikel in 'n werkkolonie opgeneem is of aangehou word, asof hy kragtens genoemde Wet na daardie werkkolonie gestuur was.

9. Vir die doeleindes van sub-artikel (2) van artikel *een* van die Wet op Vrydom van Belasting van Staatseiendom, 1931, word die perseel in Adderleystraat, Kaapstad, wat voor die veertiende dag van Maart 1942 as die hoofposkantoor te Kaapstad gebruik was, geag op die veertiende dag van Maart 1942 van die hand gesit te gewees het.

10. Ondanks die bepalings van artikel *ses* van die Wet op die Korporasie vir die Uitbreiding van Toeristeverkeer, 1938 (Wet No. 15 van 1938) word die betaling aan dr. A. J. Norval, 'n lid van die beheerraad van die Korporasie vir die Uitbreiding van Toeristeverkeer van die Suide van Afrika, by artikel *twee* van daardie Wet ingestel, van 'n bedrag van agt-en-twintig pond sewe sjielings, ten opsigte van sy bywoning van vergaderings van genoemde raad gedurende die tydperk tussen die een-en-twintigste dag van Mei en die sewentiende dag van November, 1939, hierby bekratig.

11. Artikel *seven-en-sestig* van die „Post Administratiewe Wysiging van en Scheepvaart-kombinaties Verhinderings Wet, 1911” word artikel 67 van Wet 10 van 1911.

Toekenning van subsidie op Egmont-besproeiingswerke en ontheffing van Egmont-besproeiingsraad van aanspreeklikheid vir sekere rentekoste.

Toekenning van subsidie op Schoonspruit-besproeiingswerke en ontheffing van Schoonspruit-besproeiingsraad van aanspreeklikheid vir sekere rentekoste.

Betaling van toelaes aan Kontroleur en Ouditeur-generaal.

Opname in werkkolonies in die Unie van persone uit gebiede buite die Unie.

Datum van die van die handsitting, vir doeleindes van Wet 32 van 1931, van voormalige hoofposkantoor te Kaapstad.

Bekragting van sekere betaling aan lid van Korporasie vir die Uitbreiding van Toeristeverkeer van die Suide van Afrika.

amended by the insertion after paragraph (a) thereof, of the following paragraph :

“ (a)*bis.* the Commissioner for Inland Revenue, for the purposes of any law relating to the taxation of incomes ;”.

Amendment of section 5 of Act 32 of 1914.

12. Section *five* of the Hartebeestpoort Irrigation Scheme (Crocodile River) Act, 1914, is hereby amended by the deletion in sub-section (1) of the words “ whether such land is owned by private persons or by the Government ” and the addition at the end of the proviso to the said sub-section of the following paragraph :

“ (d) no such rates shall be payable by the Government.”

Amendment of section 10 of Act 20 of 1917, as amended by section 5 of Act 21 of 1928 and section 11 of Act 33 of 1939.

13. Section *ten* of the Higher Education Additional Provision Act, 1917, is hereby amended by the addition at the end of sub-section (3) of the following words : “ or within the aggregate of the said period together with any period of suspension referred to in section *eleven*. ”.

Amendment of section 11 of Act 20 of 1917.

14. Section *eleven* of the Higher Education Additional Provision Act, 1917, is hereby amended by the addition at the end thereof of the following proviso :

“ Provided further that the Minister of Finance may, in special circumstances, from time to time suspend in respect of any particular year any such annual payment in redemption of the principal moneys advanced.”

Amendment of section 50 of Act 36 of 1919, as amended by section 3 of Act 29 of 1933, section 6 of Act 57 of 1935 and section 1 of Act 14 of 1938.

15. (1) Section *fifty* of the Public Health Act, 1919, is hereby amended—

(a) by the addition of the following proviso at the end of paragraphs (c) and (d) of sub-section (1) thereof :

“ Provided that if the Minister is satisfied that any local authority is unable, owing to lack of resources, to bear the remaining one-quarter of the said nett cost, he may, under the preceding provisions of this paragraph, refund to such local authority not more than three-fifths of the said nett cost, or after consultation with the administrator, refund to such local authority a proportion of the said nett cost, which, together with the amount to be paid by the administrator under the said provisions, exceeds nine-tenths but does not exceed the whole of the said nett cost; ”;

and

(b) by the substitution in paragraph (e) of the said sub-section for the words after the words “ section *eleven* ”, of the words “ and one-third of the total cost of dealing with such person, which has not been so recovered, may be recovered by the Minister directly from the administrator : Provided further that the Minister shall not recover less than one-tenth of the total cost of dealing with such person from a local authority, except after consultation with the administrator ; ”.

(2) Sub-section (1) shall be deemed to have come into operation on the first day of April, 1943.

Amendment of section 12 of Act 41 of 1925 as amended by section 14 of Act 49 of 1935, section 11 of Act 50 of 1937, section 20 of Act 27 of 1940 and section 16 of Act 41 of 1942.

16. (1) Section *twelve* of the Natives Taxation and Development Act, 1925, is hereby amended by the substitution in paragraph (a) for the words “ five-sixths of the ” of the words “ the whole ”.

(2) Sub-section (1) shall be deemed to have come into operation on the first day of April, 1943.

Amendment of Schedule to Act 37 of 1935.

17. The Schedule to the State Advances Recoveries Act, 1935, is hereby amended—

(a) by the substitution for paragraph 2 of the following paragraph :

“ 2. No amount shall be paid out in respect of an advance made under an agreement such as is referred to in section *five* of this Act, and no movable property sold under such an agreement shall be delivered to the debtor, until the agreement has been duly signed by the head of the department or office by which such

ACT

To apply a sum not exceeding one hundred and sixty-nine million four hundred and twenty-seven thousand eight hundred pounds towards the service of the Union, for the financial year ending on the thirty-first day of March, 1944.

BE IT ENACTED by the King's Most Excellent Majesty, B the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with sums not exceeding £103,471,600 on revenue account.

Exchequer Account charged with sums not exceeding £65,956,200 on loan account.

How money to be applied.

Minister may approve variation.

Short title.

1. The Exchequer Account of the Union is hereby charged with such sums of money as may be required for the service of the Union for the financial year ending on the thirty-first day of March, 1944, not exceeding in the aggregate the sum of one hundred and three million four hundred and seventy-one thousand six hundred pounds on revenue account as shown in column 1 of the First Schedule hereto.

2. The Exchequer Account of the Union is further charged with such sums of money as may be required for the service of the Union for the financial year ending on the thirty-first day of March, 1944, not exceeding in the aggregate the sum of sixty-five million nine hundred and fifty-six thousand two hundred pounds on loan account as shown in column 1 of the Second Schedule hereto.

3. The money appropriated by this Act shall be applied to the services detailed in the Schedules hereto, and more particularly specified in the Estimates of Expenditure from Revenue Funds [U.G. 1—1943 and U.G. 20—1943] and in the Estimates of Expenditure from Loan Funds [U.G. 19—1943], as approved by Parliament, and to no other purpose: Provided that in the case of the sum of three million four hundred thousand pounds for capital expenditure of railways and harbours, shown under Loan Vote "A" in the Second Schedule, the authority granted by this Act shall be deemed to apply only to the transfer of that sum from the Consolidated Revenue Fund to the Railway and Harbour Fund, and the expenditure of the said sum shall be in accordance with any appropriation made by Parliament in that behalf.

4. With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same vote: Provided that no excess shall be incurred on the sums appearing in column 2 of the Schedules hereto, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedules.

5. This Act shall be known as the Appropriation Act, 1943.

To apply a sum of money not exceeding fifty-five million five hundred and four thousand two hundred and fifty-nine pounds from the Railway and Harbour Fund for the services of the railways and harbours for the year ending the thirty-first day of March, 1944.

(Assented to 28th April, 1943.)

BE IT ENACTED by the King's Most Excellent Majesty, the B Senate and the House of Assembly of the Union of South Africa, as follows :—

Railway and
Harbour Fund to
be charged with
£55,504,259.

1. The Railway and Harbour Fund is hereby charged with such sums of money as may be required for the services of the railways and harbours of the Union for the year ending the thirty-first day of March, 1944, not exceeding in the whole for revenue services the sum of forty-nine million nine hundred and fourteen thousand pounds and for capital and betterment services five million five hundred and ninety thousand two hundred and fifty-nine pounds.

How moneys to be
applied

2. The moneys appropriated by this Act for revenue services shall be applied to the purposes set forth in the First Schedule hereto and more particularly specified in the Estimates of Expenditure [U.G. 5—1943] as approved by Parliament and for capital and betterment services to the purposes set forth in the Second Schedule hereto and more particularly specified in the Estimates of Expenditure [U.G. 6—1943] as approved by Parliament, but no portion of the sum of one million nine hundred and six thousand five hundred and eighty pounds contributed from the Betterment Fund specified in the Third Schedule shall be utilized for expenditure except for the purposes falling under heads numbered 2 to 9 inclusive in the said Second Schedule.

Minister may
authorize varia-
tions.

3. With the approval of the Minister of Railways and Harbours a saving on any of the heads set out in the First and Second Schedules to this Act may be made available for any excess of expenditure on any other head in the same Schedule : Provided that no excess shall be incurred on any sum appearing in column 2 of either of the said Schedules and that savings thereon shall not be available for any purpose other than that for which the money is hereby appropriated as indicated in those Schedules : Provided further that the amount appearing in column 3 of the Second Schedule may be made available for any services falling under heads numbered 2 to 8 inclusive in that Schedule.

Lines under
construction.

4. In the case of the service falling under Head No. 1 of the Second Schedule the total expenditure on any line under construction shall not exceed the amount prescribed by law as the maximum amount which may be expended thereon.

5. The moneys appropriated by this Act for capital and betterment services shall be provided from the sources set out in the Third Schedule hereto.

6. This Act shall be known as the Railways and Harbours Appropriation Act, 1943.
