MAXIMUM PRICES OF MEAT.**

**PRYSBEHEER.
MAKSIMUM PRYSE VAN VLEIS.**

In terms of regulation 3 of War Measure No. 100 of 1942, I, EDWARD JAMES CREAN, Price Controller, hereby withdraw Government Notice No. 1097 of the 15th June, 1943.

NOTE.—The effect of the above withdrawal is to postpone the price fixation of meat throughout the Union excepting Cape Town, Witwatersrand, Pretoria and Durban until completion of the investigation which is now proceeding.
