Hierby word ter algemene inligting bekendgemaak dat weens die dood van Sy Eksellensie die Goewerneur-generaal van die Unie van Suid-Afrika, die Hoogedelagbare Nicolaas Jacobus de Wet, Lid van die Mees Eervolle Geheime Raad van Sy Majesteit, Hoofregter van Suid-Afrika, die Regering van die Unie aanvaar het, as die Amptenaar Belas met die Uitoefening van die Uitvoerende Gesag van die Unie van Suid-Afrika, met ingang vanaf die 17de dag van Julie 1943.

It is hereby notified for general information that owing to the death of His Excellency the Governor-General of the Union of South Africa, the Right Honourable Nicolaas Jacobus de Wet, a Member of His Majesty's Most Honourable Privy Council, Chief Justice of South Africa, assumed the Government of the Union, as the Officer Administering the Government of the Union of South Africa, with effect from the 17th day of July, 1943.
