##### MAKSIMUM PRYSE VAN VLEI.

1. Ek, EDWARD JAMES CREAN, Pryskontroleur, handelende kragtens regulasies 3 en 9 van Oorlogsmaatregel No. 100 van 1942, skryf hierby voor dat met ingang van 6 September 1943—

(1) die maksimum prys waarteen die goedere in die Eerste en Tweede Lyste hiervan aangegee op die vermelde plekke deur 'n handelaar verkoopt mag word aan—

(a) 'n ander handelaar;

(b) 'n skip of die eienaars, agent, kaptein of ander offisier van 'n skip of iemand wat namens 'n skip of sodanige eienaars, agent, kaptein of offisier koop; of

(c) enige land-, vloot- of lugmag of iemand wat namens so'n mag koop, bereken moet word teen die tariewe wat in vermelde Lyste aangegee word;

met dien verstande dat genoemde aflewering op die perseel van die koper insluit; en met dien verstande verder dat wanneer die verkoper nie aflewer nie genoemde prys met 'n bedrag ten aansien van karweikoste van die plek van die verkoper na dié van die koper bereken teen een penny per myl per 100 pond van sodanige goedere, verminder moet word;

(2) die maksimum prys waarteen die goedere in die Derde en Vierde Lyste hiervan aangegee op die vermelde plekke deur 'n kleinhandelaar aan iemand anders verkoopt mag word bereken moet word teen die tariewe in vermelde Lyste aangegee;

(3) elke handelaar in subparagraaf (1) hiervan vermeld ten tyde van die aflewering van die vleis 'n faktuur met 'n serienummer aan die koper moet oorhandig waarop die volgende besonderhede verstrek word:—

(a) Die naam en adres van die verkoper;

(b) die naam en adres van die koper;

(c) die datum van verkoop;

(d) 'n noukeurige beskrywing (met inbegrip van die graad) van die verkoopde goedere;

(e) die gewig van elke artikel op die faktuur aangetoon;

(f) die prys per 100 pond of per 1 pond van elke artikel, die totale prys van elke artikel en die gesamentlike prys van al die artikels op die faktuur;

(4) elke handelaar in subparagraaf (2) hiervan vermeld verplig is om—

(a) as die totale prys van die vleis wat aan iemand in 'n enkele transaksie verkoopt word £5 of meer is; of

(b) as die totale prys minder as £5 is en die koper eis 'n faktuur of kwitansie;

aan die koper ten tyde van die aflewering van die vleis 'n gedateerde faktuur te oorhandig waarop 'n serienummer voorkom en wat die besonderhede in subparagraaf (3) hiervan voorgeskryf, verstrek;

(5) iedereen wat ooreenkomsdig subparagrafe (3) en (4) hiervan 'n faktuur moet verskaf 'n afskrif daarvan vir 'n tydperk van twee jaar vanaf die datum van die faktuur moet behou en dat iedereen aan wie 'n faktuur ooreenkomsdig subparagraaf (3) gegee word vermelde faktuur vir diesselfde tydperk moet bewaar; en

(6) elke handelaar in subparagraaf (2) hiervan vermeld die prys in die Derde en Vierde Lyste hiervan aangegee en van toepassing in die gebied waarin sy besigheidsplek geleë is, duidelik leesbaar in albei offisiële tale in sy winkel moet vertoon op 'n plek wat vir die publiek goed sigbaar en maklik toeganklik is; met dien verstande dat as so'n handelaar se winkel in Port Elizabeth, Oos-Londen, Bloemfontein, Kimberley en Pietermaritzburg geleë is hy nie verplig is vermelde prys voor 15 September 1943 te vertoon nie.

#### PRICE CONTROL.

##### MAXIMUM PRICES OF MEAT.

1. In terms of regulations 3 and 9 of War Measure No. 100 of 1942, I, EDWARD JAMES CREAN, Price Controller, hereby prescribe that with effect from 6th September, 1943—

(1) the maximum prices at which the goods specified in the first and second Schedules hereto may be sold at the specified places by a dealer to—

(a) any other dealer;

(b) any ship or the owners, agents, captain or other officer of any ship or any person buying on behalf of any ship or of any such owner, agent, captain or officer, or

(c) any military, naval or air forces whatsoever or any person buying on behalf of any such forces

shall be calculated at the rates specified in the said Schedules provided that the said prices shall include delivery to the premises of the purchaser; provided further that where delivery is not made by the seller, the said prices shall be reduced by an amount in respect of transport charges from the premises of the seller to those of the purchaser calculated at the rate of one penny per mile per 100 lb. of such goods;

(2) the maximum prices at which the goods specified in the Third and Fourth Schedules hereto may be sold at the specified places by a retail dealer to any other person shall be calculated at the rates specified in the said Schedules;

(3) every dealer referred to in sub-paragraph (1) hereof shall give to the purchaser at the time of the delivery of the meat a serially numbered invoice giving the following particulars—

(a) the name and address of the seller;

(b) the name and address of the purchaser;

(c) the date of the sale;

(d) an exact description (including the grade) of the goods sold;

(e) the weight of each item shown on the invoice;

(f) the price per 100 lb. or per 1 lb. of each item, the total price of each item and the aggregate price of all the items on the invoice;

(4) every dealer referred to in sub-paragraph (2) hereof shall—

(a) if the total price of the meat sold to any person in any single transaction is £5 or more; or

(b) if the total price is less than £5, and an invoice or receipt is demanded by the purchaser; give to the purchaser at the time of the delivery of the meat a serially numbered and dated invoice setting forth the particulars prescribed in sub-paragraph (3) hereof;

(5) every person who, in terms of sub-paragraphs (3) and (4) hereof, is required to give an invoice shall retain a copy thereof for a period of two years from the date of the invoice and every person to whom an invoice is given in terms of sub-paragraph (3) shall retain the said invoice for a like period; and

(6) every dealer referred to in sub-paragraph (2) hereof shall display the prices specified in the Third and Fourth Schedules hereto and applicable to the area wherein his business premises are situated, in both official languages, in clearly legible form and at a place in his shop which is prominent and easily accessible to the public; provided that any such dealer whose shop is situated in Port Elizabeth, East London, Bloemfontein, Kimberley and Pietermaritzburg shall not be obliged to display the said prices before 15th September, 1943.

2. For the purpose of paragraph 3 hereof "local authority" means a Municipality, City Council, Town Council, Borough Council, Town Board, Village Manage-

stadbestuur, dorpsbestuur, dorpsbestuurraad, plaaslike raad, gesondheidskomitee of malarialkomitee.

3. Vir doeleindes van hierdie kennisgewing beteken—

„Kaapstad” die gebiede onder die regbsbevoegdheid van die plaaslike besture te Kaapstad, Bellville, Vishoek, Goodwood, Milnerton, Parow en Pinelands;

„Durban” die gebiede onder die regbsbevoegdheid van die plaaslike besture te Durban, Amanzimtoti, dorp Claremont, Hillcrest, Isipingo-strand, Kloof, Malvern, Pinetown, Umbogintwini, Umhlali, Verulam, Westville en 'n gebied binne 'n omtrek van 'n halwe myl van die spoorwegstasie by Doonside;

„Witwatersrand” die gebiede onder die regbsbevoegdheid van die plaaslike besture te Alberton, dorp Alexandra, Benoni, Boksburg, Brakpan, Edenvale, Elsburg, Germiston, Johannesburg, Krugersdorp, Randfontein, Roodepoort-Maraisburg en Springs, en die gebied binne 'n omtrek van 'n myl van die grens van die gebied van die plaaslike bestuur op die dorp Alexandra;

„Pretoria” die gebiede onder die regbsbevoegdheid van die plaaslike besture te Pretoria, Hercules en Pretoria-Noord;

„Oos-Londen” die gebiede onder die regbsbevoegdheid van die plaaslike besture te Oos-Londen, Amalinda en Woodbrook;

„Port Elizabeth” die gebiede onder die regbsbevoegdheid van die plaaslike besture te Port Elizabeth, Amsterdamhoek, Redhouse en Schoenmakerskopp;

„Bloemfontein”, „Kimberley” en „Pietermaritzburg” die gebiede onder die regbsbevoegdheid van die plaaslike besture respektiewelik te Bloemfontein, Kimberley en Pietermaritzburg; en omvat—

„skip” nie 'n vaartuig wat in die Unie geregistreer is en gewoonlik besig is met vis te treil of met walvis te vang nie.

3. For the purpose of this notice—

“Cape Town” means the areas under the jurisdiction of the local authorities at Cape Town, Bellville, Fish Hoek, Goodwood, Milnerton, Parow and Pinelands;

“Durban” means the areas under the jurisdiction of the local authorities at Durban, Amanzimtoti, Claremont Township, Hillcrest, Isipingo Beach, Kloof, Malvern, Pinetown, Umbogintwini, Umhlali, Verulam, Westville and the area within a radius of half a mile of the railway station at Doonside;

“Witwatersrand” means the areas under the jurisdiction of the local authorities at Alberton, Alexandra Township, Benoni, Boksburg, Brakpan, Edenvale, Elsburg, Germiston, Johannesburg, Krugersdorp, Randfontein, Roodepoort-Maraisburg and Springs, and the area within one mile of the boundary of the area of the local authority at Alexandra Township;

“Pretoria” means the areas under the jurisdiction of the local authorities at Pretoria, Hercules and Pretoria North;

“East London” means the areas under the jurisdiction of the local authorities at East London, Amalinda and Woodbrook;

“Port Elizabeth” means the areas under the jurisdiction of the local authorities at Port Elizabeth, Amsterdamhoek, Redhouse and Schoenmakerskopp;

“Bloemfontein”, “Kimberley” and “Pietermaritzburg” mean the areas under the jurisdiction of the local authorities at Bloemfontein, Kimberley and Pietermaritzburg respectively;

“ship” does not include a vessel registered in the Union and ordinarily engaged in fish trawling or whale catching operations.

4. Government Notice No. 1322 of 20th July, 1943 (Maximum Prices of Meat), as amended by Government Notices No. 1404 of 30th July, 1943, No. 1446 of 11th August, 1943, and No. 1483 of 13th August, 1943, is hereby withdrawn as from 6th September, 1943.
