In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 1711 of 20th July, 1950 (Maximum Prices of Cigarettes and Tobacco) by—

- (1) the insertion in the First Schedule thereto after the words "Mills Filtertips" of the word "Blue";  
(2) the insertion in the First Schedule thereto of the following new brand of cigarettes:—

**MAXIMUM PRICES OF HIDES AND HIDE PIECES.**

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby, throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:—

1. Fix the maximum price at which hide pieces (including leg and cheek pieces) may be sold by any person to any other person—
  - (1) at eleven shillings per 100 lb. in the case of sundried or dry-salted hide pieces;
  - (2) at seven shillings per 100 lb. in the case of wet-salted hide pieces; and
  - (3) at five shillings per 100 lb. in the case of green (uncured) hide pieces.
2. Fix the maximum prices at which hides produced or cured in the Union may be sold by any person to a tanner at the prices specified in the Schedule hereto.
3. Withdraw Government Notice No. 1683 of 20th July, 1950 (Maximum Prices of Hides).

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay—

1. fix the maximum price at which a bronze welding rod manufactured in the Union that is of a diameter specified in the Schedule hereto may be sold by any person, except in the case of sales by a dealer to another dealer, at the price specified in the said Schedule opposite such diameter;
2. withdraw Government Notice No. 1675 of 20th July, 1950 (Maximum Prices of Bronze Welding Rods Manufactured in the Union).

## CONTROL OF EXPORTS.

I, ERIC HENDRIK LOUW, Minister of Economic Affairs, acting under and by virtue of the powers vested in me by War Measure No. 146 of 1942, read with War Measure No. 75 of 1945, hereby order as follows:

1. Paragraph 3 of Government Notice No. 2019 of 20th September, 1946, is hereby withdrawn.

2. Government Notice No. 1864 of 5th September, 1947, as amended by Government Notices Nos. 2576 of 5th December, 1947; 429 of 20th February, 1948; 819 of 16th April, 1948; 1493 of 16th July, 1948; 1572 of 23rd July, 1948; 637 of 1st April, 1949; 717 of 19th August, 1949; 260 of 3rd February, 1950; 1911 of 4th August, 1950, and 2018 of 18th August, 1950, is hereby amended by—

(1) inserting the following new paragraph 3, the existing paragraphs 3 and 4 becoming 4 and 5 respectively: “3. No goods contained, packed or wrapped in any of the commodities mentioned in Schedule A hereto under the heading ‘Controller of Jute Goods’ may be exported from the Union unless the exportation of such goods is authorised by an export permit issued by the Secretary for Commerce and Industries; provided that this regulation shall not apply to—

(a) exports to Bechuanaland Protectorate, Basutoland and Swaziland; and

(b) wool and mohair contained in woolpacks.”

(2) Deleting the Note appearing under the heading “Controller of Jute Goods” in Schedule A hereto.

EXPLANATORY NOTE.—The effect of this Notice is that wool and mohair contained in woolpacks is no longer subject to export permit.
