Under and by virtue of the powers in me vested by sections *three* and *four* of the Superior Courts Criminal Jurisdiction Ordinance, 1903 (Ordinance No. 10 of 1903, Transvaal), as amended by section *eight* (4) of Act No. 54 of 1949, I do hereby give notice that the above court will be held for the Districts of Witbank, Middelburg, Belfast including Carolina, Lydenburg, Sabie, Nelspruit and Barberton.
