**ACT**

**To apply a further sum not exceeding one million nine hundred and forty-nine thousand six hundred and twenty pounds towards the service of the Union for the year ending on the thirty-first day of March, 1951.**

*(English text signed by the Governor-General.)  
(Assented to 21st March, 1951.)*

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with sums not exceeding in the whole £1,880,870 on revenue account.

**1.** The Exchequer Account is hereby charged with such sums of money as may be required for the service of the Union (and chargeable to revenue account) during the year ending on the thirty-first day of March, 1951, not exceeding in the whole the sum of one million eight hundred and eighty thousand eight hundred and seventy pounds, in addition to the sums with which that Account has been charged by the Appropriation Act, 1950 (Act No. 49 of 1950) and the Additional Appropriation Act, 1951 (Act No. 2 of 1951).

Exchequer Account charged with sums not exceeding in the whole £68,750 on loan account.

**2.** The Exchequer Account is further charged with such sums of money as may be required for the service of the Union (and chargeable to loan account) during the year ending on the thirty-first day of March, 1951, not exceeding in the whole the sum of sixty-eight thousand seven hundred and fifty pounds, in addition to the sums with which that Account has been charged by the Appropriation Act, 1950 (Act No. 49 of 1950) and the Additional Appropriation Act, 1951 (Act No. 2 of 1951).

How money to be applied.

**3.** The money appropriated by this Act shall be applied to the services detailed in the Schedule hereto, and more particularly specified in the Second Estimates of Additional Expenditure [U.G. 20—1951], as approved by Parliament, and to no other purpose.

Minister may approve variation.

**4.** With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same vote: Provided that no excess shall be incurred on the sums appearing in column 2 of the Schedule hereto, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedule.

Short title.

**5.** This Act shall be called the Second Additional Appropriation Act, 1951.

**DIT WORD BEPAAL** deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg:—

1. Die Skatkisrekening word hiermee belas met die somme geld wat nodig mag wees vir die diens van die Unie vir die boekjaar wat op die een-en-dertigste dag van Maart 1951 eindig, maar gesamentlik hoogstens eenmiljoen agthonderd en tagtigduisend agthonderd en sewentig pond op die Inkomsterekening benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1950 (Wet No. 49 van 1950) en die Addisionele Begrotingswet, 1951 (Wet No. 2 van 1951) belas is. Skatkisrekening belas met somme gesamentlik hoogstens £1,880,870 op inkomsterekening.
2. Die Skatkisrekening word verder belas met die somme geld wat nodig mag wees vir die diens van die Unie vir die boekjaar wat op die een-en-dertigste dag van Maart 1951 eindig, maar gesamentlik hoogstens agt-en-sestigduisend sewehonderd en vyftig pond op die Leningsrekening, benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1950 (Wet No. 49 van 1950) en die Addisionele Begrotingswet, 1951 (Wet No. 2 van 1951) belas is. Skatkisrekening belas met somme gesamentlik hoogstens £68,750 op leningsrekening.
3. Die geld wat deur hierdie Wet beskikbaar gestel word moet aangewend word vir die dienste opgenoem in die aangehegte Bylae en met meer besonderhede vermeld in die Tweede Begroting van Addisionele Uitgawes [U.G. 20—1951], soos deur die Parlement goedgekeur, en vir geen ander doel nie. Hoe die geld bestee moet word.
4. Met die goedkeuring van die Minister van Finansies mag 'n besparing onder die een subhoof van 'n begrotingspos aangewend word tot dekking van te grote uitgawe onder 'n ander subhoof of van uitgawe onder 'n nuwe subhoof van dieselfde begrotingspos: Met dien verstande dat die somme wat voorkom in kolom 2 van die Bylae by hierdie Wet nie oorskry mag word nie en daarop gemaakte besparings ewemin aangewend mag word vir enige ander doel as waarvoor die geld hierby toegestaan word soos aangedui in die gemelde Bylae. Die Minister kan 'n afwyking goedkeur.

**ACT**

To apply a sum of money not exceeding one hundred and thirty-seven million eight hundred and one thousand four hundred and ninety-five pounds from the Railway and Harbour Fund for the services of the railways and harbours for the year ending the thirty-first day of March, 1952.

(Afrikaans text signed by the Governor-General.)

(Assented to 21st March, 1951.)

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Railway and Harbour Fund to be charged with £137,801,495.

1. The Railway and Harbour Fund is hereby charged with such sums of money as may be required for the services of the railways and harbours of the Union for the year ending the thirty-first day of March, 1952, not exceeding in the whole for revenue services the sum of one hundred and eleven million two hundred and seventy-eight thousand pounds and for capital and betterment services the sum of twenty-six million five hundred and twenty-three thousand four hundred and ninety-five pounds.

How moneys to be applied.

2. The moneys appropriated by this Act for revenue services shall be applied to the purposes set forth in the First Schedule hereto and more particularly specified in the Estimates of Expenditure [U.G. 5—1951] as approved by Parliament, and for capital and betterment services to the purposes set forth in the Second Schedule hereto and more particularly specified in the Estimates of Expenditure [U.G. 6—1951] as approved by Parliament, but no portion of the sum of two million eight hundred and sixty-five thousand four hundred and ninety-five pounds contributed from the Betterment Fund specified in the Third Schedule shall be utilized for expenditure except for the purposes falling under heads numbered 2 to 10 inclusive in the said Second Schedule.

Minister may authorize variations.

3. With the approval of the Minister of Transport a saving on any of the heads set out in the First and Second Schedules to this Act may be made available for any excess of expenditure on any other head in the same Schedule: Provided that no excess shall be incurred on any sum appearing in column 2 of either of the said Schedules and that savings thereon shall not be available for any purpose other than that for which the money is hereby appropriated as indicated in those Schedules: Provided further that the amount appearing in column 3 of the Second Schedule may be made available for any services falling under heads numbered 2 to 9 inclusive in that Schedule.

Lines under construction.

4. In the case of the service falling under Head No. 1 of the Second Schedule the total expenditure on any line under construction shall not exceed the amount prescribed by law as the maximum amount which may be expended thereon.

Sources from which moneys appropriated will be provided.

5. The moneys appropriated by this Act for capital and betterment services shall be provided from the sources set out in the Third Schedule hereto.
