PRICE CONTROL.

MAXIMUM PRICES OF "LANGFOS" RAW ROCK PHOSPHATE.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby, throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay,—

- (1) fix the maximum price at which "Langfos" raw rock phosphate may be sold by any person—
 - (a) to any person other than a farmer at seventy-seven shillings per ton (2,000 lb.) in bags f.o.r. Bellville;
 - (b) to a farmer at sixty-six shillings per ton (2,000 lb.) in bags f.o.r. Bellville.
- (2) withdraw Government Notice No. 1702 of 20th July, 1950 (Maximum Prices of Langfos Raw Rock Phosphate).

PRICE CONTROL.

MAXIMUM PRICES OF GALVANISED CORRUGATED SHEETS.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby amend Government Notice No. 1083 of 4th May, 1951, by the substitution of paragraphs 1 and 2 hereof for paragraphs 1 and 2 thereof:—

1. Fix the maximum price at which within the area bounded by the following points, which are themselves included, namely Bank, Pienaar's River, Largo, Magaliesberg, Eerste Fabriek, Houtpoort, Brits, Welgedacht and Wolvehoek, a new galvanised corrugated sheet, gauge No. 24, of any length exceeding 5 feet up to and including 12 feet, manufactured in the Union—

- (a) may be sold by an original purchaser to a reseller, as follows:—
 - (i) If the sheet is of eight three-inch corrugations, at 17d. per linear foot;
 - (ii) if the sheet is of ten three-inch corrugations, at 20²/₁₆d. per linear foot;
- (b) may, except in the case of a sale by any original purchaser to a reseller, be sold by any person to any other person as follows:—
 - (i) If the sheet is of eight three-inch corrugations, at 17¹¹/₁₆d. per linear foot;
 - (ii) if the sheet is of ten three-inch corrugations, at 21⁵/₁₆d. per linear foot.

2. Fix the maximum price at which, at any place in the Union outside the area mentioned in paragraph 1 hereof, a new galvanised corrugated sheet, gauge No. 24, of any length exceeding 5 feet up to and including 12 feet, manufactured in the Union—

- (a) may be sold by an original purchaser to a reseller, as follows:—
 - (i) If the sheet is of eight three-inch corrugations, at 16¹⁴/₁₆d. per linear foot;
 - (ii) if the sheet is of ten three-inch corrugations, at 20d. per linear foot;

- (ii) if the sheet is of ten three-inch corrugations, at $21\frac{3}{16}$ d. per linear foot;

provided that to the foregoing prices there may be added the actual cost of transportation incurred from the source of supply to the premises of the seller, and also *two-sixteenths of a penny* per linear foot per twenty-five miles or portion thereof in respect of road transportation to the seller's premises from the station or siding to which the sheets are consigned, where such premises are not less than five miles from such station or siding.

NOTE.—The effect of this notice is to increase the prices of galvanised corrugated sheets by a further $\frac{4}{16}$ d. per foot in the case of sheets of eight three-inch corrugations and by $\frac{5}{16}$ d. per foot in the case of sheets of ten three-inch corrugations. BEEF PRICES PAYABLE TO PRODUCERS IN CONTROLLED AREAS.

It is hereby notified that the Livestock and Meat Industries Control Board, constituted in terms of section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 14 of the said scheme, decided that it will, during the period stated in the Schedule hereto in the controlled areas specified in the said Schedule buy cattle carcasses from producers of slaughter animals, in the case of—

- (a) any sound carcase, at a price calculated in accordance with the rate specified in the said Schedule;
- (b) any detained carcase, at a price calculated at a rate ten per cent. less than the rate specified in the said Schedule;

in respect of that controlled area for a carcase of the class or grade specified in that Schedule.

For the purpose of the aforesaid decision—

“controlled area” shall mean any area specified in Schedule 1 to Government Notice No. 2097 of 1950, which shall, in terms of a decision of the Board, be an area to which the provisions of this Notice shall apply;

“detained carcase” and “sound carcase” shall have the meanings thereto assigned in clause 1 of the Schedule to Government Notice No. 2100 of 1950.

Government Notice No. 849 of 6 April, 1951, is hereby repealed.
