In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby further amend Government Notice No. 1653 of 20th July, 1950 (Maximum Prices of Wearing Apparel sold by Clothing Manufacturers, and Maximum Charges for Cutting, Making and Trimming, Making and Trimming, Cutting and Making or Making only of Wearing Apparel), as amended by Government Notice No. 1020 of the 27th April, 1951, by the insertion in group 1 of the First Schedule thereto of the following new item 1 B hereto.

## PRICE CONTROL.

## MAXIMUM PRICES OF AGRICULTURAL LIME AND FERTILIZING MATERIALS.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby, throughout the Union excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:—

1. Fix the following prices as the maximum prices at which the goods mentioned may be sold by any person to any other person—

2. Direct that the foregoing maximum prices do not include the cost of bags and that where any of the goods mentioned are sold bagged the maximum prices as specified may be increased by *one shilling* per bag.

3. Direct that the descriptive terms used in paragraph 1 bear the meanings which they customarily bore in the trade immediately prior to the issue of this notice.

4. Fix the maximum price at which agricultural lime may be sold by any person to any other person at *seventeen shillings and sixpence* per ton (2,000 lb.) in bulk and at *twenty-five shillings* per ton (2,000 lb.) bagged.

5. Direct that, in the case of agricultural lime that, at the request of the purchaser is sold bagged, there may be added to the aforesaid price of twenty five shillings a deposit of *fifteen shillings* per ton (2,000 lb.) which shall be refunded to the purchaser upon the return, carriage forward, to the seller of the bags in which the lime was despatched.

6. Direct that where any of the goods mentioned above is railed to or to the order of the buyer, the maximum prices shall be free on rail sender's station.

7. Withdraw Government Notice No. 1700 of 20th July, 1950 (Maximum Prices of Agricultural Lime and Fertilizing Materials).

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby:—

1. (1) Fix the maximum price at which fresh milk may be sold to a distributor within the Municipal Area of Bloemfontein by a producer or may be purchased by such a distributor from a producer at *two shillings* per gallon.

(2) Fix the maximum price at which fresh milk may be sold to a distributor in the Cape Peninsula by a producer or may be purchased by such a distributor from a producer at *two shillings and three and one-half pence*.

(3) Fix the maximum price at which fresh milk may be sold to a distributor within the Municipal Area of Kimberley by a producer or may be purchased by such a distributor from a producer at *two shillings and twopence* per gallon.

(4) Fix the maximum price at which fresh milk may be sold to a distributor at Durban or Pietermaritzburg by a producer or may be purchased by such a distributor from a producer at *two shillings and fourpence* per gallon.

(5) Fix the maximum price at which fresh milk may be sold to a distributor in the Port Elizabeth Area by a producer or may be purchased by such a distributor from a producer at *two shillings and twopence* per gallon.
