MAXIMUM PRICES OF HOUSEHOLD ELECTRICAL APPLIANCES AND OIL BURNING REFRIGERATORS.—GRASS MOWERS.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby further amend Government Notice No. 1658 of 20th July, 1950 (Maximum Prices of Household Electrical Appliances and Oil Burning Refrigerators), as amended by Government Notices Nos. 2154 of the 1st September, 1950, and 2732 of the 3rd November, 1950, by the addition of the words "and electrical lawn mowers" after the word "polishers" in Category 1 of the Schedule thereto.
