(b) of a make, description and model not specified in the Schedule hereto at the cost of such typewriter to the importer thereof plus 85 per cent. of such cost.

2. Fix the maximum price at which any reconditioned or any second-hand (used) typewriter may be sold by any person to any other person—

(a) of a make, description and model specified in column 3 of the said Schedules less 35 per cent. of such price;

(b) of a make, description and model not specified in the Schedule hereto at the price of such typewriter, when new, determined in accordance with paragraph 1 (b) above, less 35 per cent.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Dried Fruit Board, referred to in section 2 of the Dried Fruit Scheme, published by Proclamation No. 332 of 1949, has in terms of section 18 of the said Scheme, and with my approval, amended the prohibitions made known by Government Notice No. 2038 of 3rd August, 1951, in the manner indicated in the Schedule hereto.

No person shall move, or cause or permit to be moved, any pigs out of, into, through or from one place to another place within the area defined in the Schedule hereto except under the authority of a written permit issued by a Government Veterinary Officer, or otherwise than in accordance with the conditions specified in such permit.

This prohibition shall not apply in the case of pigs for slaughter consigned from areas outside the defined area and transported direct by rail to the municipal abattoirs at Benoni, Brakpan, Germiston, Johannesburg, Krugersdorp, Pretoria, Springs or Vereeniging.

2. No person shall move, or cause or permit to be moved any pig carcasses, or any uncooked portions thereof, including ham, bacon, and pork sausages, or any pig hair or manure, out of the area defined in the Schedule hereto except under the authority of a written permit issued by a Government Veterinary Officer, or otherwise than in accordance with the conditions specified in such permit.

3. All owners of pigs in the area defined in the Schedule hereto shall confine such pigs in pig-proof camps, styes, pens or runs.

4. For the purposes of the order specified in paragraph 1 hereof “place” shall mean a farm or a subdivision of a farm, or that portion of a farm or subdivision of a farm to which pigs have been confined by a Government Veterinary Officer.

SCHEDULE.

The area comprising the Magisterial Districts of Randfontein, Krugersdorp, Roodepoort, Johannesburg, Germiston, Boksburg, Benoni, Brakpan, Springs, Nigel, Heidelberg, Vereeniging, Pretoria and Bronkhorstspuit.

NOTE.—The attention of persons concerned is invited to the terms of the Swine Fever Regulations published under Government Notice No. 638 of the 14th June, 1915, and to the terms of section *sixteen* (c) of Act No. 14 of 1911, regarding the destruction without compensation of pigs moved in contravention of the Act or the regulations.
