CUSTOMS ACT, 1944.—TEMPORARY SUSPENSION OF DUTY ON IRON AND STEEL SHEETS NOT WORKED UP IN ANY WAY EXCEPT COATED WITH TIN.

I, NICOLAAS CHRISTIAAN HAVENGA, Minister of Finance, in terms of the powers vested in me by section *eighty-one* of the Customs Act, 1944, hereby suspend until the 4th day of May, 1954, the duty of 3 per cent *ad valorem* provided for in item 122 (b) of the Customs Tariff in respect of iron and steel sheets not worked up in any way except coated with tin.

NOTE.—In terms of section *eighty-one* of the Customs Act the suspension of the duty will not come into operation until fourteen days after the publication of this notice.

SPECIAL INSURANCE LEVY AND COMPENSATION PAYABLE ON CATTLE SLAUGHTERED IN CONTROLLED AREAS.—AMENDMENT.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Livestock and Meat Industries Control Board, referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 16 of the said Scheme, with my approval, amended the levy payable in terms of the Schedule to Government Notice No. 2101 of 1950, as amended, in the manner set out in the Schedule hereto.

The above provisions will come into operation on the date of publication hereof.
