**MAXIMUM PRICES OF GROCERIES.—AMENDMENT.**

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 252 of 12th February, 1954 (Maximum Prices of Groceries), by the insertion of the words "raisins and" after the word "than" in category 8—Fruits, dried (S.A.) other than those controlled by the Dried Fruit Board—of the Fifth Schedule thereof.
