MAXIMUM PRICES OF GROCERIES.—SUGAR.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Harry de Lacy Burnham, Price Controller, hereby amend Government Notice No. 252 of 12th February, 1954 (Maximum Prices of Groceries) as amended by Government Notice No. 1829 of 3 September, 1954, by the substitution of the item in the Schedule hereto for the corresponding item in the Fourth Schedule thereto.

BEEF PRICES PAYABLE TO PRODUCERS IN
CONTROLLED AREAS.

It is hereby notified that the Livestock and Meat Industries Control Board, constituted in terms of section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has under the powers vested in it by section 14 of the said Scheme, decided that it will, during the period stated in the Schedule hereto, in any controlled area specified in the said Schedule, buy cattle carcasses derived from cattle received at any abattoir in such controlled area in accordance with the provision of a permit issued by the Board in the case of—

- (a) any sound carcass, at a price calculated in accordance with a rate specified in the said Schedule;
- (b) any detained carcass, at a price calculated at a rate fifteen per cent less than the rate specified in the said Schedule;

in respect of that controlled area for a carcass of the class or grade specified in that Schedule, in respect of the period during which the animal from which the carcass is derived, is so received; provided that if an animal is not slaughtered during the week in which it is received as aforesaid and the rate for calculating the price specified in respect of the week during which the animal is slaughtered, is higher than the rate specified in respect of the week during which the animal was so received, the Board will pay a price calculated at the rate specified in respect of the week during which the animal is slaughtered, unless the slaughtering was deferred at the instance or request of the owner of the animal or his agent.

For the purpose of the aforesaid decision—

“controlled area” shall mean any area specified in the Schedule to Proclamation No. 138 of 1953;
“detained carcass” and “sound carcass” shall have the meaning thereto assigned in clause 1 of the Schedule to Government Notice No. 1304 of 1953, as amended.

Government Notice No. 1683 of 1954, is hereby repealed.
