Hierby word vir algemene inligting bekendgemaak dat dit Sy Eksellensie die Goewerneur-generaal behaag het om, kragtens die bevoegdheid hom verleen by artikel *elf* van die Wet op Seevisserye, 1940 (Wet No. 10 van 1940), soos gewysig, die regulasies afgekondig ingevolge genoemde Wet en gepubliseer by Goewermentskennisgewing No. 1353 van 1 Julie 1955, soos gewysig by Goewermentskennisgewing No. 135 van 27 Januarie 1956, te wysig in die mate in die bylae hiervan aangedui.

**WYSIGING VAN REGULASIES.**

**DEEL VIII.**

*Vangs met Nette in Valsbaai.*

Skrap Regulasie 6 en vervang met—

6. Niemand mag, binne Valsbaai, in die gebied begrens deur 'n reguit lyn, getrek vanaf Kaap Hangklip tot by Kaappunt, en deur die strande van genoemde baai—

- (a) enige soort sleepnet of enige soort Deense seën of enige ander soort net wat op so 'n wyse gebruik word dat dit oor die seabodem sleep, gebruik nie: Met dien verstande dat die bepalings van hierdie paragraaf nie die gewone gebruik van strandtrekseëns verbied nie;
- (b) enige net vir die vang van pelsers, maasbankers of makriel—
  - (i) vir die doeleindes van inmaak of vervaardiging van vismeel, visolie of vismestof; of
  - (ii) vir verkoop aan iemand vir die doeleindes van inmaak of vervaardiging van vismeel, visolie of vismestof, gebruik nie.

**SEA FISHERIES ACT, 1940: AMENDMENT OF  
REGULATIONS.**

It is hereby notified for general information that His Excellency the Governor-General has been pleased, under the powers vested in him by Section *eleven* of the Sea Fisheries Act, 1940 (Act No. 10 of 1940), as amended, to amend the regulations promulgated under the said Act and published in Government Notice No. 1353 dated 1st July, 1955, as amended by Government Notice No. 135 dated 27th January, 1956, to the extent set out in the Schedule hereto.

**AMENDMENT OF REGULATIONS.**

**PART VIII.**

*Netting in False Bay.*

Delete regulation 6 and substitute—

6. No person shall, within False Bay, in the area bounded by a straight line drawn from Cape Hangklip to Cape Point and by the shores of the said Bay, use—

- (a) a trawl-net of any kind, or a Danish seine-net of any kind, or any other kind of net operated in such manner as to drag over the sea-floor: Provided that the provisions of this paragraph shall not prohibit the use in the customary manner of beach trek-seine nets;
- (b) any net for the catching of pilchards, maasbankers or mackerel—
  - (i) for the purpose of canning or the production of fish meal, fish oil or fish fertilizer; or
  - (ii) for sale to any person for the purpose of canning or the production of fish meal, fish oil or fish fertilizer.
