ACT**To amend the Cannon Island Settlement Management Act, 1939.***(English text signed by the State President.)*
*(Assented to 14th February, 1962.)***BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section *ten* of the Cannon Island Settlement Management Act, 1939, is hereby amended—
 - (a) by the insertion in sub-section (1) after the word "land" of the words "to donate movable property,"; and
 - (b) by the insertion in sub-section (2) after the word "land" of the words "or donate movable property,".
2. This Act shall be called the Cannon Island Settlement Management Amendment Act, 1962.

ACT**To amend the Douglas Irrigable Areas Board Act, 1937.***(Afrikaans text signed by the State President.)*
*(Assented to 14th February, 1962.)***BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section *seven* of the Douglas Irrigable Areas Board Act, 1937 (hereinafter referred to as the principal Act), is hereby amended by the substitution in sub-section (3) for the words "in person or by proxy" of the words "in person only".
2. Section *fifteen* of the principal Act is hereby amended by the deletion in paragraph (a) of the words "and voting by proxy at any such election".
3. This Act shall be called the Douglas Irrigable Areas Board Amendment Act, 1962.
