**DRIED FRUIT SCHEME.**

**MAXIMUM PRICES OF DRIED FRUIT.— AMENDMENT.**

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Dried Fruit Board, referred to in section 2 of the Dried Fruit Scheme, published by Proclamation No. 332 of 1949, as amended, has, in terms of section 18 of the said scheme, and with my approval, amended the prohibition made known by Government Notice No. 520 of 30th March, 1961, in the manner indicated in the Annexure hereto.

And I further make known that the said amendment shall become operative on the date of publication of this notice.

**ANNEXURE.**

The Annexure to the said Government Notice No. 520 of 1961, is hereby amended by the substitution of the Schedule hereto for the Schedule thereto:—

 (xi) may be increased by 1c per lb. if the fruit is sold packed in 5-lb. "Vac-u-gas" bags;  
 (xii) may be increased by 2c per lb. if the fruit is sold packed in A.10 tin cans;  
 (xiii) may be increased by 4c per lb. if the fruit is sold packed in 2-lb. tin cans.

## SPECIAL LEVY ON DRIED FRUIT.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Dried Fruit Board, referred to in section 2 of the Dried Fruit Scheme, published by Proclamation No. 332 of 1949, as amended, has, in terms of section 17 of that Scheme, and with my approval, imposed a special levy as set out in the Annexure hereto, on the classes of dried fruit mentioned therein, in substitution of Government Notice No. 521 of 30th March, 1961.

And I further make known that the said special levy shall come into operation on the date of publication hereof.

Vir die toepassing van hierdie kennisgewing beteken „verkoopprijs” die bruto opbrengs behaal deur die produsent, en in die geval van droëvrugte wat deur die Raad verkoop word, is genoemde verkoopprijs die netto opbrengs daarvan na aftrek van alle verkoopskoste maar uitsluitende die Raad se administrasiekoste en enige heffing betaalbaar.

There is hereby imposed on dried fruit, of the classes mentioned hereunder, sold by the producers thereof, a special levy at the rate as shown for each class:—

Prunes.....	4½ per-cent of the selling price thereof.
Currants.....	3½ per cent of the selling price thereof.
Sultanas.....	5 per cent of the selling price thereof.
Bleached Sultanas.....	5 per cent of the selling price thereof.
Thompson's Seedless Raisins.....	5 per cent of the selling price thereof.
Raisins.....	5 per cent of the selling price thereof.
Stalk Raisins.....	½c per pound weight.
Stalk Muscatel raisins..	½c per pound weight.
Loose Muscatel raisins	½c per pound weight.

For the purpose of this notice “selling price” means the gross realisation by the producer and in the case of dried fruit sold through the Dried Fruit Board, the said selling price shall be the net realisation thereof after deduction of all selling costs, but excluding the Board's administrative costs and any levies payable.
