**GOVERNMENT NOTICE****MINISTRY OF TRANSPORT.****COMMISSION OF INQUIRY INTO THE CO-ORDINATION OF TRANSPORT IN SOUTH AFRICA.**

No. 356.]

[12th March, 1965.

It is hereby notified for general information that the State President has been pleased to appoint a Commission of Inquiry into the Co-ordination of Transport in South Africa, with the following terms of reference:—

With due regard to—

- (a) the legal provisions applicable to the South African Railways concerning the balancing of its budget, and the fact that subsidising of the Railways by the Central Government is limited to the services mentioned in Sections 105 and 106 of the Republic of South Africa Constitution Act, 1961 (Act No. 32 of 1961); and
- (b) the relevant road systems and the standards and carrying capacity of the roads,

to investigate and report upon—

- (i) the role which the different forms of transport such as railway, road, air, pipe-line and shipping in the Republic of South Africa and the territory of South West Africa must fulfil to promote the development of the national economy in the most efficient manner;
- (ii) the nature of the control measures and administrative machinery necessary to ensure that the role determined for each form of transport, in accordance with paragraph (i), is fulfilled in the most efficient manner, either separately or by way of co-ordination with one or more of the other forms of transport; and
- (iii) any other matter which the Minister of Transport may refer to the Commission.

Om, met inagneming van—

- (a) die wetlike bepalings wat op die Suid-Afrikaanse Spoorweë van toepassing is betreffende die balansering van sy begroting, en die feit dat subsidiëring deur die Sentrale Regering aan die Spoorweë beperk is tot dienste wat in artikels 105 en 106 van die Grondwet van die Republiek van Suid-Afrika, 1961 (Wet No. 32 van 1961), genoem word; en
- (b) die betrokke padstelsels en die standarde en dravermoë van die paaie, ondersoek in te stel na en verslag te doen oor—
- (i) die rol wat die verskillende vorms van vervoer soos spoorweg, pad, lug, pypeleiding en skeepvaart in die Republiek van Suid-Afrika en die gebied Suidwes-Afrika moet vervul om die ontwikkeling van die landsekonomie op die doeltreffendste wyse te bevorder;
- (ii) die aard van die beheermaatreëls en die administratiewe masjinerie wat nodig sal wees om te verseker dat die rol wat vir elke vorm van vervoer bepaal is ooreenkomsdig paragraaf (i), op die doeltreffendste wyse vervul word, hetsofsonderlik, hetsof by wyse van koördinering met een of meer van die ander vorms van vervoer; en
- (iii) enige ander saak wat deur die Minister van Vervoer aan die Kommissie opgedra mag word.
