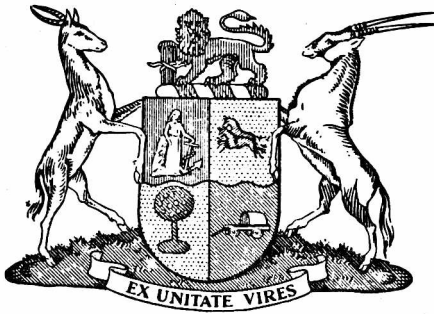

AREAS OF JURISDICTION: CAPE PENINSULA, CAPE TOWN AND BELLVILLE RENT BOARDS.

It is hereby notified for general information that the Honourable the Minister of Community Development has under and by virtue of the powers vested in him by section four of the Rents Act, 1950 (Act No. 43 of 1950), as amended, dissolved the Cape Peninsula, Bellville, Somerset West, Strand and Stellenbosch Rent Boards with jurisdiction over the areas described in Government Notices Nos. 780 of 22nd May, 1964, 1960 of 20th December, 1963 and 67 of 10th January, 1941 and has with effect from the date of publication of this notice constituted Rent Boards for the Cape Peninsula, Cape Town and Bellville, respectively, with jurisdiction over the areas described in the schedules hereto.

DURBAN NORTHERN RENT BOARD.
AREA OF JURISDICTION.
