In die Bedryf vir die Vervoer van Goedere, die Bedryf vir die Verkoop en Aflowering van Sand, die Klipbreeknywerheid, die Klipgroefnywerheid, die Baksteenvervaardigingsnywerheid, die Sementproduktenywerheid, die Sementvervaardigingsnywerheid en die Mineralewaternywerheid, in die landdrosdistrikte Alberton, Benoni, Boksburg, Brakpan, Germiston, Heidelberg (Tvl.), Johannesburg, Kempton Park, Klerksdorp, Krugersdorp, Nigel, Oberholzer, Potchefstroom, Pretoria, Randfontein, Roodepoort, Springs, Vanderbijlpark, Vereeniging, Westonaria (wat voorheen deel uitgemaak het van die landdrosdistrikte Randfontein, Roodepoort en Vanderbijlpark), Witbank, Bloemfontein, Kroonstad en Sasolburg, uitgesonderd enige Bantoegebied, wanneer die pos van 'n werknemer wat die werk verbonde aan die bestuur van 'n motorvoertuig verrig, om enige rede van welke aard ook al deur sodanige werknemer ontruim word, of wanneer so 'n pos as 'n nuwe pos geskep word, word sodanige werk gereserveer vir Blanke persone en mag geen persoon wat nie 'n Blanke persoon is nie, sodanige werk verrig nie.

SCHEDULE.

1. *Application and Scope of the Determination.*

In the Goods Transportation Trade, the Trade for the Sale and Delivery of Sand, the Stonecrushing Industry, the Quarrying Industry, the Brick Manufacturing Industry, the Cement Products Industry, the Cement Manufacturing Industry and the Mineral Water Industry, in the Magisterial Districts of Alberton, Benoni, Boksburg, Brakpan, Germiston, Heidelberg (Tvl.), Johannesburg, Kempton Park, Klerksdorp, Krugersdorp, Nigel, Oberholzer, Potchefstroom, Pretoria, Randfontein, Roodepoort, Springs, Vanderbijlpark, Vereeniging, Westonaria (which previously formed part of the Magisterial Districts of Randfontein, Roodepoort and Vanderbijlpark), Witbank, Bloemfontein, Kroonstad and Sasolburg, excluding any Bantu area, whenever the post of an employee who performs the work of driving a motor vehicle is for any reason whatsoever vacated by such employee, or whenever such a post is created as a new post; such work is reserved for White persons, and no person who is not a White person may perform such work.

2. *Definitions.*

In this Determination, unless otherwise defined in this clause or unless the context otherwise indicates, any word or expression to which a meaning has been assigned in the Industrial Conciliation Act, 1956 (Act No. 28 of 1956), as amended, shall have the same meaning when used in this Determination, and—

“unladen weight” means the weight of any vehicle or trailer as expressed in a licence or certificate issued by a licensing authority in respect of such vehicle or trailer;

“work of driving a motor vehicle” means the driving of a vehicle used for the transportation of goods in the Magisterial Districts referred to in clause 1 and which is not propelled by means of human or animal power, but does not include the driving of a vehicle—

(a) the unladen weight of which, together with the unladen weight of any trailer or trailers attached to or drawn by such vehicle, is less than 10,000 lb;

(b) driven through the Magisterial Districts referred to in clause 1 without loading or unloading any goods within the said Districts;

(c) on the premises of an employer, including the direct crossing of a public road;

(d) from outside the Magisterial Districts referred to in clause 1, which on unconnected, irregular and infrequent occasions unloads goods in the said Districts or loads goods there for unloading outside such Districts.

STATE-AIDED INSTITUTIONS ACT, 1931.—REGULATIONS: AMENDMENT.

Under and by virtue of the powers vested in him by section 7 of the State-aided Institutions Act, 1931 (Act No. 23 of 1931), the Minister of National Education has amended the regulations published under Government Notice No. R. 91 of the 14th January 1966, as amended by Government Notice No. R. 1274 of the 25th August 1967, by the addition of the following Part:—

“PART IX.**Exceptional Cases.**

88. If in the opinion of the Minister the circumstances of a case justify a departure from any provision of these regulations, he may deal with the case as he may deem fit: Provided that no action taken in terms of this regulation in respect of any person shall be detrimental to him.”
