KENNISGEWING VAN BEPERKING TEN OPSIGTE
VAN DIE ONTTREKKING EN GEBRUIK VAN
WATER VIR LANDBOUDOELEINDES.—ORANJE-
RIVIER, KAAPPROVINSIE.

1. Hierby word vir algemene inligting bekendgemaak dat die Minister van Waterwese kragtens die bevoegdheid aan hom verleen by artikel 9A van die Waterwet, 1956 (Wet No. 54 van 1956), weens die abnormale droogtetoe-stand en die ernstige afname in die vloeï van die Oranje-rivier, besluit het dat dit in die openbare belang is dat die onttrekking en gebruik van openbare water vir besproeiingsdoeleindes uit die Oranjerivier stroom af van die samevloeiing van die Oranje- en Vaalrivier, beheer en gereguleer word om sodoende te verseker dat daar genoeg-same voorrade water vir primêre doeleindes, dit is vir huishoudelike en veeuiplingsgebruik, beskikbaar sal wees vir alle oewereienaars en persone wat afhanklik is van water uit genoemde rivier vir stedelike gebruik, huis-houdelike gebruik en vir veeuipling en om 'n billike ver-delung van sodanige water wat vir besproeiingsdoeleindes beskikbaar mag wees te bewerkstellig onder die oewer-eienaars wat geregtig is op die gebruik van sodanige water vir landboudoeleindes.

2. Ten einde dat die beheermaatreëls wat hierbo beoog word, so vinnig en vlot moontlik toegepas word, delegeer ek, Jacobus Johannes Fouché, in my hoedanigheid van Minister van Waterwese, kragtens artikel 165 van genoemde Waterwet die bevoegdheid by artikel 9A van genoemde Wet aan my verleen, aan die Seksie-ingenieur te Upington.

NOTICE OF CURTAILMENT IN RESPECT OF THE
ABSTRACTION AND USE OF WATER FOR
AGRICULTURAL PURPOSES.—ORANGE RIVER,
CAPE PROVINCE.

1. It is hereby notified for general information that the Minister of Water Affairs has, by virtue of the powers vested in him by section 9A of the Water Act, 1956 (Act No. 54 of 1956), on account of the abnormal drought conditions and the serious decrease in the flow of the Orange River, decided that it is in the public interest that the abstraction and use of public water for irrigation purposes from the Orange River down stream of the confluence of the Orange River and the Vaal River, shall be controlled and regulated so as to ensure a sufficient supply of water for primary purposes, i.e. for household and stockwatering purposes, for all riparian owners and persons who are dependent upon water from the said river for urban, household and stockwatering purposes, and to effect an equitable distribution of such water as may be available for irrigation purposes amongst the riparian owners entitled to use such water for agricultural purposes.

2. In order that the control measures envisaged above should be exercised as expeditiously and smoothly as possible, I, Jacobus Johannes Fouché, in my capacity as Minister of Water Affairs hereby delegate, in terms of section 165 of the said Water Act, the powers conferred on me by section 9A of the said Act to the Circle Engineer at Upington.
