It is hereby notified that the State President has assented to the following Act which is hereby published for general information:—

No. 12 of 1969: Additional Appropriation Act, 1969.

Act No. 12, 1969

ADDITIONAL APPROPRIATION ACT, 1969.

ACT

To apply a further sum of money towards the service of the Republic for the financial year ending on the thirty-first day of March, 1969.

(Assented to 7th March, 1969.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Consolidated Revenue Fund charged with sum of money as shown in column 1 of Schedule 1, on Revenue Account.

Consolidated Revenue Fund charged with sum of money as shown in column 1 of Schedule 2, on Bantu Education Account.

Consolidated Revenue Fund charged with sum of money as shown in column 1 of Schedule 3, on Loan Account.

How money to be applied.

Minister may approve variation.

Short title.

1. The Consolidated Revenue Fund of the Republic is hereby charged, on the Revenue Account, with such sums of money as may be required for the service of the Republic for the financial year ending on the thirty-first day of March, 1969, as shown in column 1 of Schedule 1, in addition to the sums with which that Account has been charged by the Appropriation Act, 1968 (Act No. 88 of 1968).

2. The Consolidated Revenue Fund of the Republic is further charged, on the Bantu Education Account, with such sums of money as may be required for the service of the Republic for the financial year ending on the thirty-first day of March, 1969, as shown in column 1 of Schedule 2, in addition to the sums with which that Account has been charged by the Appropriation Act, 1968 (Act No. 88 of 1968).

3. The Consolidated Revenue Fund of the Republic is further charged, on the Loan Account, with such sums of money as may be required for the service of the Republic for the financial year ending on the thirty-first day of March, 1969, as shown in column 1 of Schedule 3, in addition to the sums with which that Account has been charged by the Appropriation Act, 1968 (Act No. 88 of 1968).

4. The money appropriated by this Act shall be applied to the services detailed in the Schedules, and more particularly specified in the Estimate of Additional Expenditure from the Revenue Account, the Bantu Education Account and the Loan Account as submitted to and approved by Parliament, and to no other purpose: Provided that in the case of the sum for capital expenditure by the Postal Administration, shown under Loan Vote "A" in column 2 of Schedule 3, the authority granted by this Act shall be deemed to apply only to the transfer of that sum from the Consolidated Revenue Fund to the Post Office Fund, and the expenditure of the said sum shall be in accordance with an appropriation made by Parliament in that behalf.

5. With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same vote: Provided that the sums appearing in column 2 of the Schedules shall not be exceeded, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedules.

6. This Act shall be called the Additional Appropriation Act, 1969.

Tot aanwending van 'n verdere som geld vir die diens van die Republiek vir die boekjaar wat op die een-en-dertigste dag van Maart 1969 eindig.

(Engelse teks deur die Staatspresident geteken.)
(Goedgekeur op 7 Maart 1969.)

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Die Gekonsolideerde Inkomstefonds van die Republiek word hierby op die Inkomsterekening belas met die somme geld wat nodig is vir die diens van die Republiek vir die boekjaar wat op die een-en-dertigste dag van Maart 1969 eindig, soos uiteengesit in kolom 1 van Bylae 1, benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1968 (Wet No. 88 van 1968), belas is.

2. Die Gekonsolideerde Inkomstefonds van die Republiek word verder op die Bantoe-onderwysrekening belas met die somme geld wat nodig is vir die diens van die Republiek vir die boekjaar wat op die een-en-dertigste dag van Maart 1969 eindig, soos uiteengesit in kolom 1 van Bylae 2, benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1968 (Wet No. 88 van 1968), belas is.

3. Die Gekonsolideerde Inkomstefonds van die Republiek word verder op die Leningsrekening belas met die somme geld wat nodig is vir die diens van die Republiek vir die boekjaar wat op die een-en-dertigste dag van Maart 1969 eindig, soos uiteengesit in kolom 1 van Bylae 3, benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1968 (Wet No. 88 van 1968), belas is.

4. Die geld wat deur hierdie Wet beskikbaar gestel word, moet aangewend word vir die dienste in besonderhede in die Bylaes vermeld en meer omstandig uiteengesit in die Begrotting van Addisionele Uitgawes uit die Inkomsterekening, die Bantoe-onderwysrekening en die Leningsrekening, soos aan die Parlement voorgelê en deur die Parlement goedgekeur, en vir geen ander doel nie: Met dien verstande dat, in die geval van die som aan kapitaaluitgawes deur die Posadministrasie wat voorkom onder Leningsbegrottingspos „A” in kolom 2 van Bylae 3, die magtiging by hierdie Wet verleen, geag word van toepassing te wese slegs op die oordrag van daardie som van die Gekonsolideerde Inkomstefonds na die Poskantoorfonds, en die besteding van gemelde som plaas moet vind ooreenkomstig 'n beskikbaarstelling van die Parlement wat daarop betrekking het.

5. Met die goedkeuring van die Minister van Finansies kan 'n besparing onder die een subhoof van 'n begrottingspos aangewend word tot dekking van uitgawes bo die gemagtigde bedrag onder 'n ander subhoof, of van uitgawes onder 'n nuwe subhoof van dieselfde begrottingspos: Met dien verstande dat die somme wat in kolom 2 van die Bylaes voorkom, nie oorskry mag word nie, en besparings daarop ewemin aangewend mag word vir enige ander doel as dié waarvoor die geld hierby toegestaan word soos in gemelde Bylaes aangedui.

6. Hierdie Wet heet die Addisionele Begrotingswet, 1969. Kort titel.
