Act No. 7, 1969

NATIONAL FILM BOARD AMENDMENT ACT, 1969.

ACT

To amend the National Film Board Act, 1963, so as to alter therein the designation of the Minister and of certain Departments of State; and to provide for grants-in-aid to the National Film Board.

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Short title.

1. Section 1 of the National Film Board Act, 1963 (hereinafter referred to as the principal Act), is hereby amended by the substitution in the definition of "Minister" for the words "Education, Arts and Science" of the words "National Education".

2. Section 3 of the principal Act is hereby amended—
 (a) by the substitution in paragraph (b) of subsection (1) for the words "Education, Arts and Science" of the words "Cultural Affairs"; and by the substitution in the said paragraph for the words "Commerce and Industries" of the word "Industries"; and
 (b) by the substitution in subsection (3) for the words "Education, Arts and Science" of the words "Cultural Affairs"; and by the substitution in the said subsection for the words "Commerce and Industries" of the word "Industries".

3. Section 14 of the principal Act is hereby amended by the substitution for paragraph (a) of subsection (1) of the following paragraph:

"(a) loans granted to the board, and grants-in-aid granted to the board solely for the purpose of promoting the objects of the film institute, on such conditions as the Minister may, in consultation with the Minister of Finance, determine, out of moneys appropriated by Parliament for the purpose;".

4. This Act shall be called the National Film Board Amendment Act, 1969.

WYSIGINGSWET OP DIE NASIONALE FILMRAAD, 1969. Wet No. 7, 1969

WET

Tot wysiging van die Wet op die Nasionale Filmraad, 1963, om die benaming van die Minister en van sekere staatsdepartemente daarin te verander; en om voorsiening te maak vir hulptoekennings aan die Nasionale Filmraad.

(Goedgekeur op 7 Maart 1969.)

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 1 van die Wet op die Nasionale Filmraad, 1963 (hieronder die Hoofwet genoem), word hierby gewysig deur in die woordomskrywing van „Minister” die woorde „Onderwys, Kuns en Wetenskap” deur die woorde „Nationale Opvoeding” te vervang. Wysiging van artikel 1 van Wet 73 van 1963.
2. Artikel 3 van die Hoofwet word hierby gewysig—
 - (a) deur in paragraaf (b) van subartikel (1) die woorde „Onderwys, Kuns en Wetenskap” deur die woorde „Kultuursake” te vervang; en deur in daardie paragraaf die woorde „Handel en Nywerheid” deur die woorde „Nywerheidswese” te vervang; en Wysiging van artikel 3 van Wet 73 van 1963.
 - (b) deur in subartikel (3) die woorde „Onderwys, Kuns en Wetenskap” deur die woorde „Kultuursake” te vervang; en deur in daardie subartikel die woorde „Handel en Nywerheid” deur die woorde „Nywerheidswese” te vervang.
3. Artikel 14 van die Hoofwet word hierby gewysig deur paragraaf (a) van subartikel (1) deur die volgende paragraaf te vervang:

„(a) lenings en hulptoekennings (watter hulptoekennings aan die raad toegestaan word alleen vir die bevordering van die doelstellings van die filminstituut) op voorwaardes wat die Minister in oorleg met die Minister van Finansies bepaal, uit gelde deur die Parlement vir die doel bewillig, aan die raad toegestaan.”. Wysiging van artikel 14 van Wet 73 van 1963.
4. Hierdie Wet heet die Wysigingswet op die Nasionale Filmraad, 1969. **Kort titel.**
