Act No. 56, 1969

NATIONAL PARKS AMENDMENT ACT, 1969.

ACT

To amend the provisions of the National Parks Act, 1962, relating to the object of the constitution of a park.

*(English text signed by the State President.)
(Assented to 9th May, 1969.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Substitution of section 4 of Act 42 of 1962, as substituted by section 2 of Act 93 of 1965.

1. (1) The following section is hereby substituted for section 4 of the National Parks Act, 1962:

“Object of a park.

4. The object of the constitution of a park is the establishment, preservation and study therein of wild animal, marine and plant life and of objects of geological, archaeological, historical, ethnological, oceanographic and other scientific interest and objects relating to the said life or the first-mentioned objects or to events in or the history of the park, and the benefit and enjoyment of visitors to the park.”

(2) Subsection (1) shall be deemed to have come into operation on the seventh day of July, 1965.

Short title.

2. This Act shall be called the National Parks Amendment Act, 1969.

Tot wysiging van die bepalings van die Wet op Nasionale Parke, 1962, met betrekking tot die oogmerk met die instelling van 'n park.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. (1) Artikel 4 van die Wet op Nasionale Parke, 1962, word hierby deur die volgende artikel vervang:
„Oogmerk van 'n park.

4. Die oogmerk met die instelling van 'n park is die totstandbrenging, bewaring en bestudering daarin van die wilde dierelewe, seelewe en plantelewe en van voorwerpe van geologiese, argeologiese, historiese, etnologiese, oseanografiese en ander wetenskaplike belang en voorwerpe wat betrekking het op bedoelde lewe of eersbedoelde voorwerpe of op gebeurtenisse in of die geskiedenis van die park, en die voordeel en genot van besoekers aan die park.”.

Vervanging van artikel 4 van Wet 42 van 1962, soos vervang deur artikel 2 van Wet 93 van 1965.

(2) Subartikel (1) word geag op die sewende dag van Julie 1965 in werking te getree het.

2. Hierdie Wet heet die Wysigingswet op Nasionale Parke, Korttitel. 1969.
