Nademaal by subartikel (1) van artikel *nege* van die Wet op die Verteenwoordigende Kleurlingraad, 1964 (Wet 49 van 1964), bepaal word dat, met sekere uitsonderings, die bepalings van die Wet tot Konsolidasie van die Kieswette, 1946 (Wet 46 van 1946) *mutatis mutandis* van toepassing is met betrekking tot enige aangeleentheid rakende die verkiesing van lede van die Verteenwoordigende Kleurlingraad van die Republiek van Suid-Afrika ingevolge die bepalings van die eersgenoemde Wet;

En nademaal by subartikel (1) van artikel *veertig* van genoemde Wet tot Konsolidasie van die Kieswette bepaal word dat 'n kiesafdeling by proklamasie in stemdistrikte verdeel kan word;

So is dit dat ek verklaar dat die verskillende kiesafdelings in die provinsies van die Republiek van Suid-Afrika, soos deur die Afbakeningskommissie aangestel kragtens subartikel (1) van artikel *agt* van genoemde Wet op die Verteenwoordigende Kleurlingraad, afgebaken is, en soos aangekondig by my Proklamasie 127 op die drie-en-twintigste dag van Mei 1969, hierby verdeel word in die stemdistrikte soos aangedui in Bylaes A, B, C en D.

**PROCLAMATION**

*by the State President of the Republic of  
South Africa*

No. 204, 1969

Whereas by subsection (1) of section *nine* of the Coloured Persons Representative Council Act, 1964 (Act 49 of 1964), it is provided that, with certain exceptions, the provisions of the Electoral Consolidation Act, 1946 (Act 46 of 1946), shall *mutatis mutandis* apply with reference to any matter affecting the election of members of the Coloured Persons Representative Council of the Republic of South Africa in terms of the provisions of the first-mentioned Act;

And whereas by subsection (1) of section *forty* of the said Electoral Consolidation Act it is provided that an electoral division may, by proclamation, be divided into polling districts;

Now, therefore, I hereby declare that the several electoral divisions in the provinces of the Republic of South Africa, as delimited by the Delimitation Commission appointed in terms of subsection (1) of section *eight* of the said Coloured Persons Representative Council Act, and proclaimed by my Proclamation 127 on the twenty-third day of May 1969, are hereby divided into the polling districts as set out in Schedules A, B, C and D.

Given under my Hand and the Seal of the Republic of South Africa at Durban on this fifteenth day of July, One thousand Nine hundred and Sixty-nine.
