Tot aanwending van 'n verdere som geld van hoogstens negemiljoen sewehonderd sewe-en-negentigduisend driehonderden-vyftig rand uit die Poskantoorfonds vir die diens van die Departement van Pos- en Telegraafwese in die Republiek en die gebied Suidwes-Afrika vir die jaar wat op die een-en-dertigste dag van Maart 1970 eindig.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:

Poskantoorfonds belas met R9,797,350.

Hoe die geld bestee moet word.

Minister kan awykings goedkeur.

Kort titel.

1. Die Poskantoorfonds word hierby belas met die somme geld wat nodig is vir die diens van die Departement van Pos- en Telegraafwese in die Republiek en die gebied Suidwes-Afrika, met inbegrip van die Oostelike Caprivi Zipfel, vir die jaar wat op die een-en-dertigste dag van Maart 1970 eindig, maar gesamentlik ten bedrae van hoogstens agtmiljoen ses-honderd-en-dertienduisend tweehonderd rand vir inkomstedienste en eenmiljoen eenhonderd vier-en-tachtigduisend een-honderd-en-vyftig rand vir kapitaaldienste, benewens die somme waarmee daardie fonds deur die Poskantoorbegrotingswet, 1969 (Wet No. 35 van 1969), belas is.

2. Die geld deur hierdie Wet beskikbaar gestel, word aangewend vir die doeleindes vermeld in Bylaes 1 en 2 by hierdie Wet en met bykomende besonderhede weergegee in die Begroting van Addisionele Uitgawe [R.P. 13—1970] vir die genoemde jaar soos aan die Parlement voorgelê en deur die Parlement goedgekeur.

3. Met die goedkeuring van die Minister van Pos- en Telegraafwese kan 'n besparing op die een of ander van die subhoofde aangetoon in Bylae 1 by hierdie Wet beskikbaar gestel word vir 'n oorskryding van uitgawe op 'n ander subhoof wat voorkom in Bylae 1 by die Poskantoorbegrotingswet, 1969, en insgelyks kan 'n besparing op die een of ander van die subhoofde aangetoon in Bylae 2 by hierdie Wet beskikbaar gestel word vir 'n oorskryding van uitgawe op 'n ander subhoof wat voorkom in Bylae 2 by daardie Wet: Met dien verstande dat geen som wat in kolom 2 van Bylae 1 van die Poskantoorbegrotingswet, 1969, voorkom, oorskry mag word nie.

4. Hierdie Wet heet die Addisionele Poskantoorbegrotingswet, 1970.

POST OFFICE ADDITIONAL APPROPRIATION ACT, 1970. Act No. 1, 1970

ACT

To apply a further sum of money not exceeding nine million seven hundred and ninety-seven thousand three hundred and fifty rand from the Post Office Fund for the service of the Department of Posts and Telegraphs in the Republic and the territory of South-West Africa for the year ending on the thirty-first day of March, 1970.

(Assented to 20th February, 1970.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. The Post Office Fund is hereby charged with such sums of money as may be required for the service of the Department of Posts and Telegraphs in the Republic and the territory of South-West Africa, including the Eastern Caprivi Zipfel, for the year ending on the thirty-first day of March, 1970, not exceeding in the aggregate for revenue services the sum of eight million six hundred and thirteen thousand two hundred rand and for capital services the sum of one million one hundred and eighty-four thousand one hundred and fifty rand, in addition to the sums with which that fund has been charged by the Post Office Appropriation Act, 1969 (Act No. 35 of 1969).

2. The money appropriated by this Act shall be applied to the purposes set forth in Schedules 1 and 2 to this Act and reflected with additional particulars in the Estimates of Additional Expenditure [R.P. 13—1970] for the said year as submitted to and approved by Parliament.

How money to be

3. With the approval of the Minister of Posts and Telegraphs a saving on any of the sub-heads set out in Schedule 1 to this Act may be made available for any excess of expenditure on any other sub-head appearing in Schedule 1 to the Post Office Appropriation Act, 1969, and similarly a saving on any of the sub-heads set out in Schedule 2 to this Act may be made available for any excess of expenditure on any other sub-head appearing in Schedule 2 to that Act: Provided that no excess shall be incurred on any sum appearing in column 2 of Schedule 1 to the Post Office Appropriation Act, 1969.

4. This Act shall be called the Post Office Additional Appropriation Act, 1970. Short title.
