### REGULATIONS

(b) that I shall transcribe fully and to the best of my ability any shorthand notes/mechanical record of the proceedings of the Commission of Inquiry into an Alleged Land Bank Loan to Mr A. T. Kolver or to a Company in which he has an interest made by me or by any other person.

(2) No shorthand notes or mechanical record of the proceedings of the commission shall be transcribed except by order of the chairman.

4. An officer designated thereto and/or any legal representative thereto allowed in the discretion of the chairman may adduce evidence and arguments relating to the inquiry and cross-examine any person who gave or is giving evidence before the commission.
