PRICE CONTROL

CONDITIONS OF SALE

I, Gabriël Joseph Johannes Fourie Steyn, Price Controller, acting under the powers vested in me by section 9 of the Price Control Act, 1964 (Act 25 of 1964), do hereby, with effect from the date of publication hereof, amend Schedule A of Government Notice R. 2113 of 27 November 1970, by—

(a) the substitution for paragraph 1 of the following paragraph:

"1. Pianos, the retail selling price of which does not exceed R800 and organs, the retail selling price of which does not exceed R2 000 15 per cent 30 months";

(b) the substitution for paragraph 4 of the following paragraph:

"4. Coal stoves, the retail selling price of which does not exceed R220 15 per cent 21 months"; and

(c) the substitution for paragraph 6 of the following paragraph:

"6. Musical instruments including pianos and organs, other than those referred to in paragraph 1 20 per cent 21 months".

(a) paragraaf 1 deur die volgende paragraaf te vervang:

"1. Klaviere waarvan die kleinhandelprys nie R800 en orrels waarvan die kleinhandelprys nie R2 000 oorskry nie 15 persent 30 maande";

(b) paragraaf 4 deur die volgende paragraaf te vervang:

"4. Koolstowe waarvan die kleinhandelprys nie R220 oorskry nie 15 persent 21 maande"; en

(c) paragraaf 6 deur die volgende paragraaf te vervang:

"6. Musiekinstrumente met inbegrip van klaviere en orrels wat nie in paragraaf 1 ingesluit is nie 20 persent 21 maande".
